

ORDINANCE NO.26

An ordinance extending the corporate limits of the City of Elysian to include certain unincorporated land abutting upon the city limits.

WHEREAS, a certain petition dated the 25th day of August, 1981, requested annexation of the territory hereinafter described was duly presented to the council in and for the City of Elysian on the 14th day of September, 1981; and

WHEREAS, the quantity of land embraced within the area described in the petition imbounded as described is 4.07 acres, no part of which is included within the limits of an incorporated city or borough; and

WHEREAS, the Petition was signed by all owners; and

WHEREAS, the Town Board of Elysian Township, Le Sueur County, filed a consent to the annexation and waived the waiting period required before a city ordinance can be adopted on the annexation; and

WHEREAS, hearing was duly held by the governing body of the City of Elysian, Minnesota, on the proposed annexation after mailed notice; and

WHEREAS, the land described in the petition abuts upon the city limits of the east boundary thereof;

The Council of the City of Elysian, Minnesota, ordains;

Section 1. The City Council hereby determines:

- (1) That the annexation will be to the best interests of the city and of the territory affected;
- (2) That the territory described herein abuts upon the city limits and is suburban in character; and
- (3) That none of said territory is now included within the limits of any city or borough.

Section 2. Territory Annexed. Corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Beginning at a point on the West line of Section No. 36, Township 109 North, Range No. 24 West, Le Sueur County, Minnesota, said point being 1642.75 feet South of the West quarter corner of said Section No. 36, and said point also being the centerline of Minnesota Trunk Highway No. 60, thence North 71° 20 minutes East along the centerline of said highway 530.70 feet, thence South 08° 20 minutes East 182.00 feet

more or less to the water's edge at Lake Elysian, thence Southwesterly along the water's edge of said lake to the West line of said Section No. 36, thence North on said West line 410.56 feet more or less to the place of beginning, containing 4.07 acres, more or less, and being part of government lot No. Five (5) of said Section No. 36.

Section 3. Filing. The City Clerk is hereby directed to file certifiec copies of this Ordinance with the Minnesota Municipal Board, the Township of Elysian, the Le Sueur County Auditor, and the Secretary of State.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
