# ELYSIAN CITY COUNCIL REGULAR MEETING JANUARY 13, 2014 6:00 P.M.

The Elysian City Council met in regular session on Monday, January 13, 2014, at City Hall at 6:00 p.m.

Meeting opened with the Pledge of Allegiance to the US Flag.

On motion by Ziemer, seconded by Thayer, all voting in favor, minutes of December 9, 2013 and December 30, 2013 were approved as presented.

On motion by Stoen, seconded by McBroom, all voting in favor, to approve the agenda with the addition of the Museum under Administration, adding Roessler under Public Works, and to include an additional \$2,000 to bills approval.

No one was present for Public Comment time.

13. Regular Council meeting time and date: Second Monday of each month at 6:00 p.m. unless otherwise designated.

Discussion was held on the hardship to get members of the community to volunteer to be on the Elysian Planning and Zoning Commission. On motion by Thayer, seconded by Ziemer, all voting in favor, to hold a public hearing on February 10, 2014 at 6:00 p.m. to consider amending Ordinance #24 An Ordinance establishing a Planning and Zoning Commission for the City of Elysian, from a seven member Commission to a five member Commission.

#### Public Works - Roessler/Greenwald

Ron Greenwald explained to the Council that he had met with the City Building Inspector and the Lake Francis Park restrooms were approved as a handicap facility with a few minor things to be updated. On motion by Stoen, seconded by Ziemer, all voting in favor, to approve the moving ahead with the handicap accessible grab bars, the outdoor plaques on the door to include Braille. Also, to look into the replacement of one of the doors, and if needed, to allow a new door to be installed.

John Roessler briefed the Council on a major problem at the west pumphouse regarding two malfunctioning heaters that have become obsolete. On motion by Stoen, seconded by Thayer, to approve \$2,824.50 bill for one heater. After further discussion, Mayor Stoen retracted his prior motion, and made a motion, seconded by McBroom, all voting in favor, to approve the heater for one side of the pumphouse in the amount of \$2,824.50 and a second heater in the amount of \$2,146.00.

Councilmember Ziemer and the Council thanked the Public Works employees for their good snow removal work.

#### Administrator's update:

Nusbaum explained the request for the City of Elysian to be supportive of a request from the Lake Francis Lake Association to again this summer to have an inspector stationed at the DNR Public Access on the East edge of Lake Francis with the Lake Francis Lake Association paying all costs for the inspector. This year there is a request from DNR for grant funding to apply to the costs of hiring an inspector. On motion by Ziemer,

seconded by Thayer, all voting in favor, to approve the inspection program, and to make an application for a local government unit grant from the DNR to help defray the expenses.

Mayor Stoen stated that there still is no meeting set up between the representatives of Le County Commissioners, City Council, and the Le Sueur County Historical Society which has been a request of the Elysian City Council since October, 2013. Three letters, one from one of the Attorneys from the Society, and two responses from Attorney Moran were presented to the Council regarding communication the City Attorney had had with an Attorney for the Historical Society. Attorney Moran in his response had invited representatives of the Le Sueur County Historical Society to attend the Council meeting and answer some questions. The response from one of the Society Attorneys, Attorney Urban, was that they could not be in attendance due to other commitments. Attorney Moran was authorized to invite them to the February meeting.

EDA Administrator Kopischke addressed Hanson's concerns and stated the EDA had hired a new webmaster and he is working on the site and it should be going live sometime this week. We ran out of hours with Voyageur Web, and now it will be hosted by go.daddy, the webmaster will be Tony Deno.

Hanson stated that they are easy to do and I know, because I have done some, it does take a while. We have something good we need to keep it up keep it running like it should.

Marge Pribyl – 45 Egret Lane – Talked about the Historical Society a couple meetings ago, I mentioned my friend that had applied for membership in the Society and it took about 6 months to finally get her membership approved. She finally got approval in November, 2013. I was having lunch with that friend today and she said that now she got a letter wanting her to donate to the saw mill fund. There was a big splash in the paper about how much they had and I did not realize that they call on members to help contribute. She said she just put the letter in the file.

Jason James – 43911 43<sup>rd</sup>. Street - Talking about the Museum, he asked if anyone had been in the Museum in a couple of year? It is a mess. Absolutely terrible. The last time I was in the Museum, there was no heat. One whole room was all torn apart, there's pictures, prints stacked against each other along the wall. So, if we can do whatever we can do to get the Museum up and running again, I am all for helping on whatever I can do to help. I would like to see it going again.

# ELYSIAN CITY COUNCIL REGULAR MEETING FEBRUARY 10, 2014 6:00 P.M.

The Elysian City Council met in regular session on Monday, February 10, 2014, at City Hall at 6:00 p.m.

Meeting opened with the Pledge of Allegiance to the US Flag.

Roll Call: Mayor Clinton Stoen: Councilmembers Tom McBroom, Mary Opsahl, Brian Ziemer, Administrator Patricia Nusbaum, Deputy Clerk Lorri Kopischke, Public Works Director John Roessler, Ron Greenwald Assistant Public Works Director, and Attorney Jason Moran. Absent: Councilmember Edna Thayer.

A public hearing was held for the consideration of input from the public on the amending of the Planning and Zoning Ordinance, Ordinance # 24 - Establishing a Planning and Zoning Commission for the City of Elysian. The amendment consideration was for reducing of the Commission from a seven to a five member Commission. City Zoning Administrator Nusbaum offered the following presentation stating the importance of the Planning and Zoning Commission and the work they do.

In 1980 the Elysian City Council passed an ordinance establishing a City Planning and Zoning Commission. In that ordinance it calls for a Commission to consist of seven members. Over the years the various Councils have considered lowering the number of the members of the Commission to a number less than 7. The number usually considered was 5 due to the Council wanting an uneven number in case of a tie.

The Planning and Zoning Commission are a very vital advisory commission to the City Council. The Commission deals with all the developing and updating approximately every 5 years of the Comprehensive Land Use Plan. The plan, after much input from the citizens, is then approved by the City Council. In August of 2013 the updated Comprehensive Plan was approved.

The Commission is also responsible for the development of the Zoning Ordinance and the updating of the Zoning map. The zoning ordinance and zoning map are based off the Comprehensive Land Use Plan, which again does not become effective without Council approval.

The Planning and Zoning Commission review all new development plans and work with the developers and engineers until the plans are ready for Council review. The Commission holds a public hearing on the plans and then presents to the Council for approval. The Commission also hears all conditional use and variance requests, to include all non-conforming uses.

The Commission also performs duties and reviews as are requested by the Council. Such as researching and making recommendation on ordinances updating, including gathering material on new ordinances.

The Commission also yearly look at yards of homes in the City and make a recommendation to the Council as to a cleanup if warranted, and also any other duties so assigned by the City Council.

Tonight, the Council is being asked to consider amending the ordinance to five members or to leave as is with a seven member board.

As Zoning Administrator for the City of Elysian, I would like for the Council to consider going to a five member commission for the following reasons:

- A seven member board is a large board in which to work. When the ordinance
  was first passed, it was thought that more members would be better, but with the
  Public hearing process on most all of the reviews that are done by the Commission
  and with review by the Council, there is plenty of input that happens after the
  proposals have been presented.
- 2. Planning and Zoning Commission is not a glory position, but a huge help for the Council so that decisions can be made. Planning and Zoning is somewhat of a complicated process and all members must be willing to learn the process and maybe be somewhat knowledgeable of the process. For that reason it has been difficult for the Council to get persons from the public that are interested in serving.
- 3. Lastly, many times when working on development plans or issues with individual property owners, confidentially is necessary. With a smaller board, it is somewhat easier to keep confidentially.

#### **Public Comment:**

Mike Kauss – 6 Egret Lane – I was the chairperson for over a year on Planning and Zoning and was a member for about three years total. I do not think it is a problem to reduce to five members, I think Pat has given good reasons. But I'd like to throw out that

if you talk about it being so important to the city, as Pat emphasized on several occasions, that the current City Council might consider remunerating those people that are on the commission. It is the only one (Commission) that during the prior Administration it's funding was taken away from the members, they were not getting much to begin with, but if you really want people to care and do stuff for the City, you need to make them feel important too. I am no longer on it (Commission) and have no desire to be on any longer, but I think it would be good to give them back the stipend they had, especially if you expect them to do the work that you want done.

There were no written comments. Planning and Zoning Commissioner Gary Buchschacher verbally sent a message through the office stating that he would like to see the Council consider a five member Commission. Hearing was closed at 6:10 p.m.

On motion by Ziemer, seconded by Opsahl, all voting in favor, minutes of the January 13, 2014 regular meeting were approved as presented.

On motion by Ziemer, seconded by McBroom, all voting in favor, the agenda was approved with the addition of the following items:

- 1. Museum membership results
- 2. Report on LCHS attending meeting update

#### **Public Comment:**

Mike Kauss – 6 Egret Lane – As you proceed to take a look at whether you are going to have a five or seven membership on the Board, I would like to recommend that you be consistent in how you select people. I went through a period of time where I had to make an application, I had to come in front of the City Council, I had to answer questions about myself and my background, which I had no problem doing. Shortly, thereafter the next Mayor just decided to appoint people. I think if you are going to have a process, it should be the same for everybody. If you want to find out about people when they apply, I think you should have them come in talk to the City Council and let the public hear what they have to say, not just someone picking someone because they know them or like them or for whatever reason.

#### **Public Works**

1. Ron Greenwald brought to the Council's attention the need for a professionally painted sign for the Lake Francis Beach area. The old sign is in deteriorated condition. Park Committee will review the rules for the sign prior to having a new sign printed.

- 2. John Roessler asked the Council to consider quotes for new tractor tires. The quotes were as follows:
  - 1. Wholesale Tire Morristown \$1,388
  - 2. Good Year St. Peter \$1,487
  - 3. Good Year Faribault \$1,453

On motion by Stoen, seconded by Opsahl, all voting in favor, to approve the quote from Wholesale Tire – Morristown in the amount of \$1,388.

3. Roessler also brought up the law on reflectivity for all signs in the city including street signs. This matter will be discussed at the next regular meeting.

#### **Administration:**

Discussion was held on the consideration of amending Ordinance #24, reducing the Planning and Zoning Commission from seven members to five members. To address the public comment concern as to the process for making application to be on the Commission, applications will be required of each applicant and prior to the next regular meeting, Mayor Stoen and City Administrator will review the application(s) and one will be brought to the Council for approval.

Discussion included reinstating a monthly stipend for the Commission. It was decided to revisit this when preparing the 2015 budget, since there are no funds budgeted in the 2014 budget.

On motion by Ziemer, seconded by McBroom, all voting in favor, to approve the following amended ordinance:

# CITY OF ELYSIAN AMENDED ORDINANCE #24

# AN ORDINANCE ESTABLISHING A PLANNING COMMISSION FOR THE CITY OF ELYSIAN

The City of Elysian, herby ordains according to and for the reasons stated in MSA 462.351 and MSA 462.354, Subdivision 1:

Subd.1. The Commission shall consist of five members appointed by the Council as follows: One (1) member shall be a member of the City Council, who is appointed for a one year term; four (4) members who are residents of the city, are appointed by the Council for a three (3) year term. Every three (3) years, two (2) members of the Commission shall be

reappointed by the City Council or City Council shall appoint new members.

The City Council member shall be appointed to serve until such time as a successor is appointed by the City Council. Any Commissioner position that shall become vacant shall be filled by the City Council for the unexpired term of office, and upon the expiration of any term of office, the member appointed to the position for which such term has expired shall continue to serve until such time as a successor is appointed and qualified to assume office. Compensation for members of the Commission shall be determined by the City Council.

Subd. 2 The duties and responsibilities of the Planning Commission shall be as follows:

- a. Adopt rules for the operation of the commission, including rules pertaining to the election of officers.
- b. Conduct meetings, open to the public and in conformity with the state open meeting law, as such times deemed appropriate by the Commission.
- c. Maintain permanent minutes and records of Commission meetings and proceedings, and file such records with the City Clerk.
- d. Advise the City Council regarding planning matters, and assist the City Council in the maintenance of a Comprehensive Land Use Plan.
- e. Perform such reviews and make such recommendations, as may be requested or required by the City Council.

This Ordinance shall take effect thirty (30) days from the date of its adoption and due publication thereof.

Nusbaum reminded the Council of the Board of Appeal and Equalization Open Book Meeting for 2014 – Tuesday, April 15, 2014 from 10:00 a.m. to 6:00 p.m. at the Office of the County Assessor, Le Sueur County, Le Center, MN.- Waseca County – Monday, April 14, 2014 to April 17, 2014 – 8:00 a.m. to 4:30 p.m. - Office of the County Assessor.

A big "Thank You" to Tim Bengtson and his crew for putting up and taking down the Christmas decorations on Main Street.

On motion by Ziemer, seconded by Stoen, all voting in favor, to hold a special meeting (workshop) on Thursday, April 10, 2014 at 5:00 p.m. with the City Engineer.

On motion by Stoen, seconded by Ziemer, all voting in favor, to accept the resignation of Tim Bengtson from the Elysian Fire Department. Council expressed their thanks for his many years of service.

At the next regular meeting discussion and updates will be given on the Lake Francis restoration project which is being considered for the park area.

Mayor Stoen asked if any of the Council had received their membership to the Le Sueur County Historical Society. No one had. Stoen stated that he had been in communication with Le Sueur County Commissioner Rohlfing, but no date had been set to get into the Elysian Museum Building. Attorney Moran stated that he had twice asked if the Society representatives could be at the Council meeting, but did not receive a response.

On motion by Bills, payroll, and transfers were approved in the amount of \$126,041.62.

## **Public Comment:**

Mike Kauss -6 Egret Lane -I have lived here for six years and all I have heard of is a lot of talk about the Historical Society. That's all I have ever heard. You send a letter, send an e-mail to so and so, so and so.

Who is the authority? Who is the overall authority? Whether that building can be open or not. If it is the Le Sueur County Commissioners, why don't we get a contingency of people and go to Le Sueur County Commissioners meeting and stand up and voice our concerns. I have been here for six years and all I have heard is more talk about more talk, about more talk. I appreciate everything you are trying to do, but it is like who the heck

has the final authority? Do we need to go to a judge? Do we need to go to the State?

My tax dollars are going to a building that isn't even open. I am tired of it. I am not even sure that I even understand as to how it ever got to the way it got, but if someone has some authority, the question is, why is the Le Sueur Commissioners giving money to whoever this person is to do whatever she is doing with no accountability? Someone has to asking these questions. Is there a Judge that rules this or are these guys just a bunch of flakes. I am willing to tell them that. I do not have a problem doing this. They work for me as far as I am concerned. I am just as member of the community, I am just telling you that I am frustrated and as I am sure you are frustrated, but there has to be another step. We have a Barrister sitting here, he has got to have an idea that goes above contacting this other Attorney. There's got to be somebody more powerful above that attorney that is getting this money and doing stuff, and how did this women ever get the keys?

City Attorney Moran stated that the County Commissioner's would be the higher authority. The Commissioners budget a certain amount of funding each year for the Le Sueur County Historical Society. The Le Sueur County Historical Society is an incorporated non-profit society and has a Board that runs the society. The Society funnels the money to the various sites, one of those sites is the Elysian Museum.

Regarding Kauss's question, he suggested that a group of like-minded people go to the Le Sueur County Commissioners and air your concerns.

Jason Moran – Kilkenny - I just want to go on the record here tonight and Tim Bengtson is not here tonight, but we accepted his resignation from the Elysian Fire Department tonight. I have known Tim Bengtson for a number of years. He has been on the Fire Department for more years than I can remember. What an asset to the City of Elysian. To accept his resignation here tonight, this is kind of a special event. Tim is an excellent guy, hard working guy, given his life to this community. If he were here, I would thank him.

The Elysian City Council met in regular session on Monday, March 10, 2014, at City Hall at 6:00 p.m.

Meeting opened with the Pledge of Allegiance to the US Flag.

Roll Call: Mayor Clinton Stoen: Councilmembers Tom McBroom, Mary Opsahl, Edna Thayer, Brian Ziemer, Administrator Patricia Nusbaum, Deputy Clerk Lorri Kopischke, Public Works Director John Roessler, Ron Greenwald Assistant Public Works Director, and Attorney Jason Moran.

On motion by Ziemer, seconded by McBroom, all voting in favor, minutes of February 10, 2014 were approved as presented.

On motion by Ziemer, seconded by McBroom, all voting in favor, to approve the agenda with the addition of discussion on a city rental ordinance.

Le Sueur County Sheriff Dave Tietz and Chief Deputy Brett Mason were present to introduce themselves to the Council and those present. Tietz stated that all had been quiet in the City. He indicated that he wanted to put an update in Elysian's City Newsletter each month, just to let the citizens know what was going on. Chief Deputy Mason briefly talked about the evergreen program which is a communication program so that in cases of emergencies through phone, e-mail or other means of communication word could spread quite quickly. He stated that the County Commissioners would be reviewing the program and costs of which there would be more information at a later date. He stated that Rice, Scott, Nicollet Counties had comparable programs and the cost would be around \$11,000.

No one was present for Public Comment time.

#### Public Works - Roessler/Greenwald

1. Roessler – Water lines are freezing, one main and two service lines are frozen. Roessler requested that all residences and businesses be notified to allow one water tap to run at a steady stream no bigger than the size of a pencil. He requested that it be run day and night until April 10<sup>th</sup>. The purpose of the water running is to help to keep the service lines to each home and business from freezing and to help to keep open the main lines running in the street. It would be hoped that by doing this it will keep the property owners from having to dig

up frozen pipes running on their property and to try to keep the main lines open so that an even greater cost can be spared from having to dig up the street and replace the blacktopping. On motion by Ziemer, seconded by McBroom, all voting in favor, a letter will be delivered to each business and household the day following this meeting explaining the concern of freezing water service lines and mains, and why all properties with a water hookup, are asked to run their water at a pencil stream until April 10, 2014. The Council allowed \$30.00 on the next utility billing for each water hookup to help defray the costs for running the water. After the next billing, a look at each account as to usage will be reviewed. Contact will also be made by Face Book, e-mail, and phone.

## Administration - Nusbaum

- Brian Barnett, 1198 Lake Francis, President, Lake Francis Association, presented to the Council the proposed shoreline restoration project to be considered for placement at the end of Third Street NW along the lakeshore. The size of the project is 30 feet wide by 100 feet long. A grant was applied for and received by the Le Sueur County Environmental Services from the Environment and Natural Resources Trust Fund through the Legislative-Citizen Commission on Minnesota Resources. The grant received is in the amount of \$23,000. The considered project will be approximately \$10,000. The project will be accomplished by help from the Lake Francis Lake Association and other volunteers from the community. The City of Elysian will be involved with in-kind use of city equipment. The City will receive the grant will disburse all expenses. On motion by Opsahl, seconded by Thayer, all voting in favor, the City Council authorized the signing of the contract to move ahead with the project.
- 2. A special meeting workshop was set for March 17, 2014, at 5:00 p.m. at City Hall to discuss the consideration of a full-time Public Works Worker.
- 3. Attorney Moran explained the policy for sign retroreflectivity and the mandated guidelines for the city to be in compliance in updating all street and traffic directional signs. Council approved policy as written. On motion by Thayer, seconded by Ziemer, all voting in favor, to adopt the retroreflectivity policy as presented.
- 4. Mayor Stoen introduced Shawn Anderson, 205 Third Street NE, and asked for approval to be placed as a Commissioner on the Elysian Planning and Zoning

- Commission. On motion by Stoen, seconded by Thayer, all voting in favor, to appoint Shawn Anderson to the Elysian Planning and Zoning Commission.
- 5. Nusbaum stated that Mid Continent Cable Service have completed the updating of lines in the City of Elysian and will be in the area the next three weeks talking with residents regarding the new upgrade of the cable and internet service.
- 6. On April 10, 2014 at 5:00 p.m. a workshop meeting will be held with the City Engineer on local improvement needs.
- 7. Board of Appeal and Equalization Open Book Meeting for 2014 Tuesday, April 15, 2014 from 10:00 a.m. to 6:00 p.m. at the Office of the County Assessor, Le Sueur County, Le Center, MN. Waseca County Monday, April 14, 2014 to April 17, 2014 8:00 a.m. to 4:30 p.m.- Office of the County Assessor.
- 8. Nusbaum asked the Council, knowing that they were aware of a large building on Elysian's Main Street that is presently sitting empty, to try to be diligent and all work together to see if there would be an opportunity in attracting a business. If there is anyone on the Council who might know of someone looking for a building, to contact City Hall or the EDA so that a discussion could be held? Also consider any other empty or closed buildings that could enhance business or visitor traffic to Elysian, and to encourage owners of the buildings to contact City Hall for discussion on helping getting the buildings open for business.
- 9. Since the Planning and Zoning Commission had worked on a recommendation to the Council to consider a rental ordinance, the ordinance will be placed on the April agenda for further review.

Mayor Stoen spoke regarding still not having received word from the Le Sueur County Historical Society. He stated that his concerns were being ignored by the Le Sueur County Historical Society Board regarding his application for membership and the re-opening of the museum. He said it is getting very difficult to show support and to help them to better the museum when they will not let you join the organization. All we are trying to do is to support it. It is not coming from the City Council of Elysian, it is coming from citizens. Citizens would like to see it re-opened. I am a citizen, Tom is a citizen, we all are citizens, we just want a viable way to get it open and we keep getting denials.

Attorney Jason Moran – stated that we have invited them to come to meetings, but they do not come to meetings. Today we got a hostile letter, e-mail from Jen Urban, their

attorney, basically chastising us for discussing the museum and for us discussing the idea of trying to get it up and running again. We will continue to discuss what we believe concerns the general welfare of the City. The city would like to see it open again. I can certainly share the e-mail from Ms. Urban. It goes into detail slamming a couple Councilmembers, slamming the City Administrator, basically trying to tell us what we can or can't do, and what we should or should not be discussing at our meetings. We will be discussing items that concern the welfare of the city of Elysian. If Ms. Urban has a problem with that she can show up at a Council meeting and she can speak for herself rather than sending out nasty e-mails to Pat, Lorri, and to me (Attorney Moran).

The Council discussed the possibility of getting on the Commissioners agenda within the next couple of weeks to address their concerns with the Museum continuing to be closed.

On motion by Ziemer, seconded by Stoen, all voting in favor, bills, payroll, and transfers were approved in the amount of \$74,336.11.

Council thanked John, Ron, and Max for their great job of plowing and removing of snow throughout the city.

#### **Public Comment:**

Mike Kauss, 6 Egret Lane - I think you made the comment regarding the Historical Museum. I would think if you can get on the agenda, I think it would behoove us to let every citizen in the community know so that more of us can go to the meeting. Those Commissioners are elected, and I would be glad to stand up and tell them that if they do not do something, I will do everything I can so that they don't get elected. I really mean that. It is a joke. It is a ping pong game. If they are giving my tax dollars away to some organization to do something and I do not see any benefit, then I will hold them accountable.

It has been an unusual winter, and I definitely want to thank John, Ron and Max for work they have done. I got an infant idea. I have watched them work and I know how hard it is to take and use the front end loader, the skid loader, take the snow out in the middle of the road and take and dump it by the building, come back and get it and take it and dump it. Eventually, they get so much down there they have nowhere to put more, so they have to take the snow and haul it somewhere. I do not know where they haul it to, but I am glad it is not at my place. I think it is the time for the city council to take a look at getting more modern equipment. It may cost money. If we have more winters like this one you are going to have problems with overtime. I was going to ask for those figures, but I will not at this point in time. We need to take a look, there are equipments out there that you can go down the street where you can snow blow it right into a truck and they can then haul it away. I

think it is time for this city to take a look at that because you are spending a lot of money in overtime, but it is not just the overtime, but you are wearing the people out, and you cannot get to the street fast enough. This last snow fall, and I am very appreciative of what they do, our streets were not cleared until 3:30 p.m. in the afternoon of that snow problem we had. There are a lot of people out there that are older who will not go in their cars unless they have to, they are not going to be able to handle it. I know this city does everything they can and I appreciate it. I think it is time whether it is Johnny, Ron, or someone else who is here, I think we need to look into some more modernized equipment, whether it be the putting of a blower on a tractor...I do not know...I just know that there is equipment out there that not only picks it up and blows it, but can sweep the street..it does everything. Yes, it cost big bucks, maybe there is a grant out there. Thank you.

## **DIVISION 1. GENERALLY**

#### **Section 1. Title and Short Title.**

This Ordinance shall be known as "The Rental Housing Maintenance, Inspection and Licensing Program Ordinance of the City of Elysian, Minnesota" and is referred to herein as "this Ordinance".

## Section 2. Scope and Purpose of Standards.

- (a) For the purpose of establishing uniform rules and regulations for rental housing, the most current revision of the International Property Maintenance Code is hereby adopted, confirmed and incorporated in this Ordinance as completely as if set out in full.
- (b) In the event there is a conflict between the provisions of the Code adopted by reference within this Section and the other provisions of this Rental Housing Ordinance, the City's Code of Ordinances shall prevail.
- (c) Legislative finding. It is hereby found that there exists in the City of Elysian structures used for human habitation which are not owner occupied and are now, or may become in the future, substandard with respect to structure, equipment, or maintenance, and further that such conditions, together with inadequate provisions for light and air, insufficient protection against fire hazards, lack of proper heating, unsanitary conditions, and overcrowding, constitute a threat to public health, safety, and welfare requires the establishment and enforcement of minimum housing maintenance standards.
- (d) *Purpose*. The purpose of this Ordinance is to protect, preserve, and promote the public health, safety, and the general welfare of the people of the City; to prevent housing conditions that adversely affect the life, safety, general welfare, and health, including the physical, mental, and social well-being of persons occupying dwellings within the City of Elysian and which dwellings are not owned by said occupants, to provide minimum standards for basic equipment and facilities for light, ventilation, and thermal conditions, for safety from fire, for the use and location and amount of space for human occupancy; and for an adequate level of maintenance; to preserve the value of land and buildings throughout the City; and to provide for the administration and enforcement thereof.

- (e) Discrimination and privacy. This Ordinance shall be enforced in a nondiscriminatory manner and exclusively for the purpose of promoting public, as opposed to private, welfare. Except as may be specifically provided herein or incidental to the enforcement hereof, this Ordinance is not intended to interfere with personal privacy or with private legal rights and liabilities, including without limitation landlord/tenant and lessor/lessee relationships, and in enacting and enforcing this Ordinance, the City neither expressly nor by implication assumes any obligations or liabilities respecting such private rights or disputes, including those which involve or arise out of the nonconformity of any premises in the City to the provisions of this Ordinance.
- (f) Application. The provisions of this Housing Maintenance, Inspection and Licensing Program shall provide minimum requirements to safeguard health, property and public welfare by regulating and controlling the use, occupancy, location and maintenance of all buildings, structures and accessory structures within the City of Elysian, designed or intended to be used for human habitation; the applicable requirements contained herein shall apply to all rental structures, accessory structures, rooming houses, lodging and/or boarding houses, apartments and manufactured homes used for human habitation; and same shall not apply to owner occupied structures. Said provisions of this Ordinance shall apply irrespective of when such building may have been or may be considered altered, or repaired.
- (g) *Conflict of Ordinances*. In any case where a provision of this Ordinance is found to be in conflict with a provision of any zoning, building, fire, safety, health ordinance or code of this City, the provision that establishes the higher standard for the promotion and protection of the health and safety of the people shall prevail.
- (h) *Effect of partial invalidity*. If any subsection, paragraph, sentence, clause, or phrase of this Ordinance should be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect; and to this end the provisions of this Ordinance are hereby declared to be severable.
- (i) Alteration. Existing buildings that are altered or enlarged shall be made to conform to Uniform Building Code (UBC) insofar as new work, alterations or enlargements are concerned. If the alterations are such that they cause or threaten to cause unsafe conditions in the unaltered portions of a building or threaten the safety or safe operation of other nearby structures, then said alterations are prohibited unless the affected structures are also brought into compliance with this and/or other appropriate codes.
- (j) Requirements for repair and replacement work. Any person doing any repair and/or replacement work on any rental residential building, structure and accessory structure covered in the City of Elysian Building Code shall complete the repair and/or replacement work in compliance with the standards contained in the definitions of repair and/or replacement in the definitions section of this Ordinance.
- (k) *Relocation*. Existing buildings that are moved or relocated shall be considered as new buildings and shall comply with all requirements of this Ordinance.

## **DIVISION 2. ENFORCEMENT**

## Section 1. Enforcement/Responsibilities.

- (a) *Authority*. The Building Inspector is hereby authorized and directed to enforce all the provisions of this Ordinance.
- (b) *Right of entry*. Upon presentation of proper credentials the Building Inspector or the Building Inspector's duly authorized representatives may enter at reasonable times any building, structure, or premises in the City to perform any duty imposed upon him by this Code.
- (c) *Privacy*. The Building Inspector shall keep confidential all evidence exclusive of the inspection record, which the Building Inspector may discover or obtain in the course of any inspection made pursuant to this section and such evidence shall be considered privileged.
  - (d) Responsibilities defined.
- (1) Every owner remains liable for violations of duties imposed by this Ordinance even though an obligation is also imposed on the occupants of the owner's building, and even though the owner has, by agreement, imposed on the occupant the duty of furnishing required equipment or of complying with this Ordinance.
- (2) Every owner, or the owner's agent, in addition to being responsible for maintaining the building in a sound structural condition, shall be responsible for keeping that part of the building or premises which the owner occupies or controls in a clean, sanitary and safe condition including the shared or public areas in a building containing two or more dwelling units.
- (3) Every owner shall furnish and maintain approved sanitary facilities and shall furnish and maintain approved equipment or facilities for the prevention of insect and rodent infestation, and where infestation has taken place, shall be responsible for the extermination of any insects, rodents or other pests.
- (4) Heating Rental Properties. Every owner, operator or manager of any building who rents, leases or lets for human habitation any habitable room or unit contained within such building on terms, either expressed or implied, to supply or furnish heat to the occupants thereof, shall have the capability of maintaining a minimum temperature of 70 degrees Fahrenheit between September 1 and June 1 inclusive, from a location within the room or unit at a point three (3) feet above the floor level and not closer than thirty-six (36) inches from any wall. The heating equipment shall be properly installed and maintained throughout the year.
  - (5) All occupants shall keep their premises in a safe and sanitary condition.

#### Section 2. Hazardous buildings.

All buildings or portions thereof which are determined to be substandard as defined in this Ordinance are hereby declared to be public nuisances and shall be abated by repair,

rehabilitation, demolition or removal in accordance with the procedure specified in Chapter 1, Section 108-110 of the most recent revision of the International Property Maintenance Code.

## Section 3. Posting to prevent occupancy.

The Building Inspector may post any rental building or structure under the Building Inspector's jurisdiction to prevent further occupancy of a building that is found to be in direct violation of this Ordinance. Posting will occur if any owner, agent, licensee or other responsible person has been notified by inspection report of the items which must be corrected within a certain stated, reasonable period of time and that the responsible person or persons has failed to correct the cited items. In cases of emergency, a building or premises may be immediately posted and the occupants, if any, evacuated. No person shall remove or tamper with any placard used for posting. No person shall reside in, occupy or cause to be occupied any building, structure or dwelling that has been posted to prevent occupancy.

## Section 4. Appeals.

Whenever the Building Inspector shall take action which is disputed, or when it is claimed that the provisions of this Ordinance do not apply or that the true intent and meaning of this Ordinance have been misconstrued or wrongfully interpreted, the aggrieved party may appeal within thirty (30) days from the date of decision of the Building Inspector to the Board of Appeals. Actions of the Board may also be appealed to the Courts for final decision.

## Section 5. Procedure for conduct of hearing appeals.

(Reference Elysian City Zoning Ordinance, Section 4.0, Board of Appeals).

## Section 6. Permits and Inspections.

The following repairs are exempt from building permit requirements, if they do not affect or involve any plumbing, electrical, mechanical, structural or subsurface member and if the repair returns the affected area to its intended original condition:

Paint
Gutters/Downspouts
Trim/Moldings/Shutters/Decorations
Glass (but not window frames)
Weather-stripping/Caulking/Tuck Pointing
Walks/Landscape Masonry (if not on City easement)
Non-Structural Hardware
Finish Flooring/Carpets
Door Slabs (but not door frames)
Fences (when under 6' in height

## **DIVISION 3. DEFINITIONS**

## **Section 1. Definitions.**

Terms, words, phrases and their derivatives used but not specifically defined in this code shall have the meaning defined in the Minnesota State Building Code.

**Accessory Building or Structure:** Accessory building or structure shall mean a detached building or structure in a secondary or subordinate capacity from the main building or structure on the same premises.

**Apartment House:** Apartment house is any building, or portion thereof, that is designed, built, rented, leased, let or hired out to be occupied, or which is occupied as the home or residence of two (2) or more families living independently of each other performing their own cooking services in the apartment house. Said definition included the rented portion of an owner/occupied duplex.

**Basement:** Any floor level below the first story in a building, except that a floor level in a building having only one floor level shall be classified as a basement unless such floor level qualifies as a first story.

**Board of Appeals:** Board of Appeals, when used herein, shall mean the Board of Appeals of the City of Elysian.

**Boarding House:** A dwelling unit where lodging with or without meals is provided for compensation and occupied by three (3) or more persons, but not to exceed eight (8) persons.

**Building:** Any structure having a roof supported by columns or walls. When divided by party walls without openings, each portion of such building so separated shall be deemed a separate building.

**Building Inspector:** The Building Inspector shall be defined as the person or persons designated as Building Inspector by the City Administrator.

**Bulk Container:** Bulk Container shall mean any metal garbage, rubbish and/or refuse container having a capacity of two (2) cubic yards or greater and which is equipped with fittings for hydraulic and/or mechanical emptying, unloading and/or removal.

**Clean:** The absence of rubbish, garbage, vermin or other unsightly, offensive or extraneous matter.

**Dormitory:** Dormitory shall mean a building or group of rooms in a building used for institutional living and sleeping purposes by four (4) or more persons.

**Dwelling:** Dwelling shall mean any space wholly or partially used or intended to be used for living, sleeping, cooking, and eating: provided that temporary housing as hereinafter defined shall not be classified as a dwelling. Industrialized housing and modular construction which conform to nationally accepted industry standards and used or intended for use for living, sleeping, cooking and eating purposes shall be classified as dwellings. Single-family, two-

family and multiple family dwellings are as follows:

- (a) Dwelling, Single-Family. A residential building containing one (1) dwelling unit including detached, semi-detached and attached dwelling.
- (b) Dwelling, Two-Family. A residential building containing two (2) dwelling units including detached, semi-detached and attached dwelling.
- (c) Dwelling, Multiple Family. A building or portion thereof containing three (3) or more dwelling units, but not including a motel, hotel, or rooming house.

**Dwelling Unit:** One (1) or more rooms arranged for residential use containing cooking, living, sanitary and sleeping facilities, permanently installed, which are arranged, designed, used or intended for use as living quarters for one (1) family and for not more than an aggregate of two (2) roomers or boarders.

**Efficiency Living Units:** Efficiency living unit is any room having cooking facilities used for combined living, dining and sleeping purposes and meeting the requirements of Section 404.6 Exception, of the Uniform Housing Code.

**Egress:** Egress shall mean an arrangement of exit facilities to assure a safe means of exit from buildings.

**Family:** One (1) or more persons related by blood, marriage or adoption, including foster children, or a group of not more than four adult individuals (excluding personal care attendants, in accordance with Minnesota Statutes, Sections 256B.04, Subd. 6 and 256B.0625, Subd. 19 and Minnesota Rules, Rule 9505.0335), maintaining a common household in a dwelling unit.

**Guest:** Guest shall mean an individual who shares a dwelling unit in a non-permanent status for not more than thirty (30) days.

**Habitable Room:** Habitable room shall mean a room or enclosed floor space used or intended to be used for living, sleeping, cooking, or eating purposes, excluding bathrooms, water closet compartments, laundries, furnace rooms, pantries, kitchenettes, utility rooms of less than fifty (5) square feet of floor space, foyers, or connecting corridors, stairways, closets, storage spaces, and workshops, hobby and recreation areas. All habitable rooms shall comply with all the provisions contained herein.

**Hot Water:** Hot water shall mean water at a temperature of not less than 110 degrees Fahrenheit.

**Household:** A household shall mean a family as defined in this subdivision.

**Kitchen:** Kitchen shall mean any room used for the storage, preparation, and serving of food and that contains at least the following equipment: sink, stove or microwave oven, refrigerator, cabinets and/or shelves, and a counter or table.

**Kitchenette:** Kitchenette shall mean a small kitchen or an alcove containing cooking facilities.

**Multiple dwelling:** A building of any size or type occupied by more than four (4) families, including boarding houses and rooming houses. "Multiple dwelling" does not include hotels, motels, hospitals and homes for aged.

**Nuisance:** The following shall be defined as nuisances:

- (a) Any public nuisance known in common law or in equity jurisprudence.
- (b) Any attractive nuisance that may prove detrimental to children whether in a building, on the premises of a building, or upon an unoccupied lot. This included any abandoned wells, shafts, basements or excavations; abandoned refrigerators and motor vehicles; or any structurally unsound fences or structures; or any lumber, trash, fences, debris, or vegetation which may prove a hazard for inquisitive minors.
  - (c) Whatever is dangerous to human life or is detrimental to health.
  - (d) Overcrowding a room with occupants.
  - (e) Insufficient ventilation or illumination.
  - (f) Inadequate or unsanitary sewerage or plumbing facilities.
  - (g) Uncleanliness.
- (h) Whatever renders air, food, or drink unwholesome or detrimental to the health of human beings.

**Occupant:** Any person, firm, partnership, corporation, association, organization, corporation or other who shall be in actual possession or have charge, care or control of any dwelling within the City.

**Ordinary Summer Conditions:** Ordinary Summer Conditions shall mean a temperature of not higher than ninety-two (92) degrees Fahrenheit.

**Ordinary Winter Conditions:** Ordinary winter conditions shall mean a temperature of not lower than minus eighteen (-18) degrees Fahrenheit.

**Owner:** Any person, firm, partnership, corporation or other association who alone, jointly, or severally with others is the fee owner of record of any dwelling or dwelling unit within the City or any trustee or guardian or other representative of the fee owner, Contract for Deed vendee or, holder of a life estate.

**Person:** The word "person" shall include a corporation, firm, partnership, association, organization and any other group acting as a unit as well as individual. It shall also include an

executor, administrator, trustee, receiver or other representative appointed according to law. Whenever the word "person" is used in any section of this Ordinance prescribing a penalty or fine as to partnerships or association, the word shall include the officers, agents or members thereof who are responsible for any violation of such section.

**Plumbing:** Plumbing shall mean any and all equipment, fixtures, and connections made to water, sewer or gas lines including but not limited to the following: gas pipes, gas burning equipment, water pipes, garbage disposal units, waste pipes, water closets, sinks, installed dishwashers, lavatories, bathtubs, shower baths, installed clothes washing machines, catch basins, vents, valves and connectors.

**Premises:** Premises shall mean a parcel of land either occupied or unoccupied by any structure or structures.

**Privacy:** Privacy shall mean the existence of conditions that will permit an individual or individuals to carry out an activity commenced without interruption or interference, either by sight, sound or presence by unwanted individuals.

**Properly Connected:** Properly connected shall mean connected in accordance with accepted industry standards and/or all applicable code and ordinances of this City as from time to time enforced; provided, however, that the application of this definition shall not require the alteration or replacement of any connection in good working order and not constituting a hazard to life or health.

**Repair:** Repair shall mean to restore to a sound, acceptable state of operation, serviceability or appearance. Repairs shall be expected to last approximately as long as would the replacement by new items.

**Replace or Replacement:** Replace or replacement shall mean to remove an existing item or portion of a system and to construct or install a new item of a quality similar to that of the existing item when it was new. Replacement ordinarily takes place when repair of the item is impractical.

**Rooming House:** Rooming House shall mean any dwelling other than a hotel or motel or that part of any dwelling containing one (1) or more rooming units, and/or one (1) or more dormitory rooms in which persons either individually or as families are housed without the provision of meals.

**Space Heater:** Space Heater shall mean a self-contained, heating appliance of either the convection or radiant type and intended primarily to heat only a limited space or area such as one (1) room or two (2) adjoining rooms.

**Temporary Housing:** Temporary Housing shall mean any tent, trailer, manufactured home or any other structure used for human shelter which is designed to be transportable and which is not attached to the ground, to another structure, or to any utility system on the same premises for more than thirty (30) consecutive days.

**Water Closet:** Water Closet shall mean a toilet bowl that is flushed with water that has been supplied under pressure and equipped with a water sealed trap above the floor level.

### **DIVISION 4. DEFICIENCIES, STANDARDS AND CORRECTIONS**

#### Section 1. Built-in deficiencies exempt.

The following are built-in deficiencies and shall be exempt from compliance with the Code; provided, that such built-in deficiencies were in compliance with a building code at the time of construction and/or do not pose a hazard.

- (a) *Ceiling heights*: Any existing habitable room with less than a seven and one half (7.5) foot ceiling height shall be considered a built-in deficiency which is beyond reasonable correction.
- (b) Superficial floor areas: Any existing habitable room of less than ninety (90) square feet shall be considered a built-in deficiency and beyond reasonable correction but in no case shall the required natural light and ventilation be less that five percent (5%) of the floor area.
- (c) Any existing habitable room with window area less than ten percent (10%) of the floor area shall be considered a built-in deficiency beyond reasonable correction but in no case shall the required natural light and ventilation be less than five percent (5%) of the floor area.

#### Section 2. Space and occupancy standards.

No person shall let to another for occupancy any dwelling or dwelling unit, for the purposes of living, sleeping, cooking or eating therein, which does not comply with the following requirements:

- (a) Every dwelling unit shall have a room or portion of a room in which food may be prepared and/or cooked, which shall have adequate circulation area, and which shall be equipped with the following:
- (1) A kitchen sink in good working condition and properly connected to a water supply system which is approved by the appropriate authority and which provides at all times an adequate amount of heated and unheated running water under pressure, and which is connected to a sewer system approved by the City of Elysian.
- (2) Cabinets and/or shelves for the storage of eating, drinking, and cooking equipment and utensils and of food that does not in ordinary summer conditions require refrigeration for safe keeping; and a counter or table for food preparation; said cabinets and/or shelves and counter or table shall be of sound construction furnished with surfaces that are easily cleanable and that will not impart any toxic or harmful effect to food.

- (3) A stove, or similar device, for cooking food, and a refrigerator, or similar device, for the safe storage of food at temperatures less than forty-five (45) degree Fahrenheit but more than thirty-two (32) degrees Fahrenheit under ordinary maximum summer conditions, which are properly installed with all necessary connections for safe, sanitary and efficient operation; provided that such stove, refrigerator, and/or similar devices need not be installed when a dwelling unit is not occupied and when the occupant is expected to provide same on occupancy, and that sufficient space and adequate connections for the safe and efficient installation and operation of said stove, refrigerator and/or similar devices are provided.
- (b) Within every dwelling unit that shall be a non-habitable room which affords privacy to a person within said room and which is equipped with a flush water closet in good working condition. Said flush water closet shall be equipped with easily cleanable surfaces, be properly connected to a water system that at all times provides an adequate amount of running water under pressure to cause the water closet to be operated properly, and shall be properly connected to a sewer system which is approved by the City of Elysian. The room shall have an operable window or mechanical ventilation sufficient to provide the equivalent of five (5) air exchanges per hour.
- (c) Within every dwelling unit there shall be a lavatory sink. Said lavatory sink may be in the same room as the flush water closet, or, if located in another room, the lavatory sink shall be located in close proximity to the door leading directly into the room in which said water closet is located. The lavatory sink shall be in good working condition and properly connected to a water supply system which is approved by the appropriate authority and which provides at all times an adequate amount of heated and unheated running water under pressure, and which is properly connected to a sewer system approved by the appropriate authority. Water inlets for lavatory sinks shall be located above the overflow rim of these facilities.
- (d) Within every dwelling unit there shall be a room which affords privacy to a person within said room and which is equipped with a bathtub or shower in good working condition. Said bathtub or shower may be in the same room as the flush water closet or in another room and shall be properly connected to a water supply system which is approved by the appropriate authority and which provides at all times an adequate amount of heated and unheated water under pressure, and which in connected to a sewer system approved by the appropriate authority.
- (e) Private stairways having less than four (4) risers and serving one individual unit in need not have handrails. Decks and stairways shall have guardrails and handrails per Minnesota State Building Code.
- (f) Each dwelling unit shall have facilities for the safe storage of drugs and household poisons.
- (g) Access to or egress from each dwelling unit shall be provided without passing through any other dwelling unit.

- (h) No person shall let to another for occupancy any dwelling or dwelling unit unless all exterior doors and windows of the dwelling or dwelling unit are equipped with appropriate, functioning locking devices.
- (i) Every foundation, roof, floor, exterior and interior wall, ceiling, inside and outside stair, every porch, and every appurtenance thereto, shall be safe to use and capable of supporting the loads that normal use may cause to be placed thereon; and shall be kept in sound condition and good repair. Every inside and outside stair or step shall have uniform risers and uniform treads.
- (j) Every foundation, roof and exterior wall, door, skylight and window shall be reasonably weather-tight, water-tight and damp free, and shall be kept in sound condition and good repair. Floors, interior walls and ceilings shall be sound and in good repair. All exterior wood surfaces, other than decay resistant woods, shall be protected from the elements and decay by paint that is not lead-based paint or by other protective covering or treatment. Walls shall be capable of affording privacy for the occupants.
- (k) Every premises shall be graded, drained free of standing water, and maintained in a clean, sanitary and safe condition.
- (l) Unless other provisions are made, gutters, leaders and downspouts shall be provided and maintained in good working condition so as to provide proper drainage of storm water.
- (m) Every window, exterior door and hatchway or similar device shall be so constructed to exclude insects during that portion of the year when there is a need for protection against mosquitoes, flies and other flying insects.
- (n) Every dwelling, multiple dwelling, rooming house or accessory structure and the premises on which located shall be maintained in a rat-free and rat-proof condition.
- (1) All openings in the exterior walls, foundations, basements, ground or first floors and roofs that have a half-inch diameter or more opening shall be rat-proofed in an approved manner if they are within forty-eight (48) inches of the existing exterior ground level immediately below such openings, or if they may be reached by rats from the ground by climbing unguarded pipes, wires, cornices, stairs, roofs, and other items such as trees or vines or by burrowing.
- (2) All windows located at or near ground level used or intended to be used for ventilation, all other openings located at or near ground level, and all exterior doorways which might provide an entry for rats, shall be supplied with adequate screens or such other devices as will effectively prevent the entrance of rats into the structure.
- (3) All sewers, pipes, drains or conduits and openings around such pipes and conduits shall be constructed to prevent the ingress or egress of rats to or from a building.
  - (4) Any materials used for rat-proofing shall be acceptable to the Building Inspector.

- (o) All fences shall be constructed of approved fencing materials. Wood materials shall be protected against decay by use of paint that is not lead-based paint or by other preservative material. The permissible height and other characteristics of all fences shall conform to the appropriate statutes, ordinances, and regulations of the City of Elysian and the State of Minnesota. Wherever any egress from the dwelling opens into the fenced area, there shall be a means of egress from the premises to any public way adjacent thereto.
- (p) Accessory structures present or provided by the owner, agent, or tenant occupant on the premises of a dwelling shall be structurally sound, and be maintained in good repair and free of insects and rats, or such structures shall be removed from the premises. The exterior of such structures shall be made weather resistant through the use of decay-resistant materials or the use of lead-free paint or other preservatives.
- (q) Every plumbing fixture and all water and waste pipes shall be properly installed and maintained in good sanitary working condition. All waste system clean-out plugs must be easily accessible.
- (r) Every water closet compartment, bathroom and kitchen floor surface shall be constructed and maintained so as to be reasonably impervious to water and so as to permit such floor to be easily kept in a clean and sanitary condition.
- (s) Every plumbing fixture and pipe, every chimney, flue, and smoke pipe, and every other facility, piece of equipment, or utility which is present in a dwelling or dwelling unit, or which is required under this Ordinance, shall be constructed and installed in conformance with the appropriate statutes, ordinances and regulations of the City of Elysian and State of Minnesota.
- (t) No owner, operator, or occupant shall cause any service, facility, equipment or utility which is required under this Ordinance to be removed from or shut off from or discontinued from any occupied dwelling or dwelling unit let or occupied by said person; except for such temporary interruption as may be necessary while actual repairs or alterations are in process, or during temporary emergencies when discontinuance of service is approved by the appropriate authority.
- (u) All construction, ways and means of egress, and installation and use of equipment shall conform with the appropriate statues, ordinances and regulations dealing with fire protection of the City of Elysian and State of Minnesota.

#### Section 3. Occupancy standards.

Permissible occupancy of a dwelling unit: The maximum permissible occupancy of any rental dwelling unit shall be determined as follows:

(a) Minimum space: For the first two occupants, two hundred twenty (220) square feet of habitable room floor space and for every additional occupant thereof, at least one hundred (100) square feet of habitable room floor space.

The Elysian City Council met in regular session on Monday, June 9, 2014, at City Hall at 6:00 p.m.

Meeting opened with the Pledge of Allegiance to the US Flag.

## Water Base Charge Policy

WHEREAS, the City of Elysian provides water and sewer services to residential and commercial properties.

WHEREAS, the City of Elysian charges a recurring monthly base charge to its customers for providing water and sewer to them.

WHEREAS, effective January 1, 2015, the following recurring monthly base charges shall apply to the City of Elysian's water and sewer customers:

1. A single base charge shall apply to all single family residential properties based upon the number of hookups located on that property. For each hookup there shall be one base charge. If, however, a single family residential property has

- another, or multiple, habitable structure/s or guest cottage/s located on it, then two base charges or multiple base charges based upon the number of habitable structures thereon shall be charged.
- 2. A base charge shall apply to all commercial properties, excluding those commercial operations specifically addressed below, based upon the number of hookups located on that property. For each hookup there shall be one base charge. In addition, for any commercial operations where a single supply line is used to supply different areas or different buildings or different commercial or different residential operations a separate base charge shall apply for each of those operations.
- 3. With regard to multiple mobile homes located on a parcel of property, and mobile home parks, there shall be a base charge for every two mobile homes located on a parcel of property, regardless of whether those mobile homes are occupied or not.
- 4. With regard to campgrounds, a base charge shall be charged for every ten campsites on a parcel of property, regardless of whether they are occupied or not.
- 5. With regard to apartment buildings, a base charge shall be charged to each unit in any apartment buildings, regardless of whether they are occupied or not.
- 6. A base charge shall be applied to the Department of Natural Resources
  Building at 101 Fourth Street SW.

- 7. A base charge shall apply to the museum building located at 301 Second Street NE.
- 8. A base charge shall be charged to the genealogy building located at 303 Second Street NE.
- 9. A base charge shall be charged to the fire hall located at 202 Main Street East.
- 10. A base charge shall be applied to the Wayside Rest property located at 301 Main Street West.

This policy was adopted this 9th. day of June, 2014 and may be amended from time to time by the City Council.
