ELYSIAN CITY COUNCIL REGULAR MEETING JANUARY 14, 2019

The Elysian City Council met in regular session on Monday, January 14, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Clinton Stoen; Councilmembers Robert Houlihan, Tom McBroom, Mary Opsahl, and Dennis Schnoor; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald; City Attorney Jason Moran. Absent: City Utility Clerk Nicole Lamont.

On motion by McBroom, seconded by Houlihan, all voting in favor, to approve the minutes of the December 10, 2018 Regular Meeting and December 27, 2018 Special Year-End Meeting as presented.

On motion by Schnoor, seconded by McBroom, all voting in favor, bills, payroll, and transfers were approved in the amount of \$44,232.63.

Councilmember McBroom presented Mayor Stoen with a certificate of appreciation from the City Council and City staff for his service to the Elysian community as a City Councilmember and Mayor since 2009, and an engraved gavel commemorating his time of service as Mayor. McBroom thanked Stoen for his years of service and stated that he will be missed.

City Clerk/Administrator Kopischke administered the oath of office with Mayor Tom McBroom and Council Persons Dennis Schnoor and Bryan Suemnick answering.

Roll Call: Mayor Tom McBroom; Councilmembers Mary Opsahl, Dennis Schnoor, and Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald; City Attorney Jason Moran. Absent: City Utility Clerk Nicole Lamont.

On motion by Schnoor, seconded by Opsahl, all voting in favor, to approve the agenda of the January 14, 2019 Regular Meeting as presented.

Public Comment: None.

As McBroom was elected to the position of Mayor at the November 6, 2018 election while he was serving as a councilmember for a term that expires in January 2021, there now exists a vacancy on the Council. Resolution No, 654/19 declares that vacancy and states that the Council will fill the vacancy by appointment at the February 11, 2019 Council Meeting. The appointment is for a two (2) year term and will expire January 2021.

Councilmember Opsahl introduced the resolution and was seconded by Councilmember Schnoor.

The City Council shall vote to make the appointment at the February 11, 2019 City Council Meeting. The appointed person shall fill the vacancy until the special election held on November 3, 2020 with seating for the same occurring at the first council meeting in January 2021.

The Council then considered the remaining appointments. Opsahl asked why Jim Tatge, the current Emergency Management Director, was not being appointed to that position. McBroom stated he was looking for fresh blood, fresh faces, and new ideas.

Schnoor noted all the resources Director Tatge had provided during the September 2018 storm event. He recruited generators to keep the water tower running and crews from Mankato to run the chippers. The City couldn't ask for a better Emergency Management Director. He has done a great job with the required paperwork. This makes no sense. McBroom stated these are all good points.

Opsahl stated the 2018 Emergency Management Director did a good job. Westby has a lot of knowledge and would go a good job but there is a benefit in keeping appointments steady.

The Council then discussed the Emergency Management Director appointment again. City Attorney Moran noted that this is a Mayoral appointment per State Statute.

On motion by McBroom, seconded by Opsahl, all voting in favor, to table the appointment of the Emergency Management Director to the February 11, 2019 City Council Meeting to give time for the Mayor to meet with Tatge and discuss the appointment.

On motion by Opsahl, seconded by Suemnick, all voting in favor, the Fire Department Chief Appointments were approved as follows:

Josh Lynch, Gambling Manager, Waseca Hockey Association, stated he was present at the request of Tucker's Tavern. He stated the Association represents and serves the Waseca area. There are over 30 children from the Waterville Elysian Morristown (WEM) area who are supported through the donations of the Association. The Association donates \$1,250 per child which pays for all ice time, and some tournaments and coaching, etc. This is over \$30,000 that is being spent for the WEM area to keep the kid's fees super low. The Association also supports children from Janesville Waldorf Pemberton and New Richland Heartland Geneva for which they have zero gambling sites in those communities. They also support other non-profits and one of the 2018 scholarship winners was a WEM senior. When Tucker's Tavern approached the Association for an opportunity in Elysian, they were ecstatic about the idea as they had talked of branching out into this area.

City Attorney Moran asked if the Association had any sites in Le Sueur County. Lynch stated they do in Lexington and in Kilkenny. The Association does not have an agreement for a percentage to give back with Lexington, and with Kilkenny the agreement is to give back 10%. Moran inquired as to the arrangement with the City of Waseca. Lynch stated they are not required to give an amount back but 70% of the profits are required to stay within the City.

Moran asked if the Elysian Fire Relief held the current gambling license at Tucker's Tavern and if notice had been given to them. Lynch replied that the Fire Relief did hold the license and he did not know if notice had been given.

Schnoor asked Lynch exactly what gambling activities the Waseca Hockey Association was interested in operating at Tucker's Tavern. Lynch stated he had only come here to request bingo, but the Association would be interested in whatever would be available. They will schedule the bingo around other activities in the City as not to interfere with other organizations. He noted there could be more than one gambling license at a premise and suggested this might work at Tucker's Tavern.

On motion by McBroom, seconded by Suemnick, all voting in favor, to table the consideration of a request from the Waseca Hockey Association for a Lawful Charitable Gambling License to operate at Tucker's Tavern to the February 11, 2019 City Council meeting. The City Attorney will follow up with Lynch and more information will be provided to the Council for consideration.

Le Sueur County Chief Deputy Nick Greenig reported it has been quiet in the City this past month. He has received inquiries on the County no-wake ordinance. There will be a workshop meeting on this item on January 16, 2019 and he will let the public know when the public hearing will be held. Greenig stated the Justice Center is progressing and they will begin training staff there the end of June 2019.

Bob Chicos, Crysteel Truck Equipment, was present to answer questions on the State of Minnesota Cooperative Purchase Contract for the new truck. The truck as quoted is a Ford 550 with an 11 foot dump box. It will include a hoist with a hydraulic package. It will have strobe lights for added safety and running boards. It will have a harder floor and the sides fold down to haul larger items. It will have a 10 foot steel Vee plow. The truck as currently quoted is \$36,428.27 and they are offering a trade in value for the current F-550 truck of \$10,500.

Councilmember Suemnick, Public Works Director Greenwald, and a Crysteel Truck Equipment representative will meet prior to the February 11, 2019 City Council Meeting to discuss and develop a final quote for the truck.

Councilmember Schnoor introduced the resolution and was seconded by Councilmember Suemnick.

Jeremy Henninger, owner of the parcel of land located at 182 Ridge Road NE, Elysian, Minnesota has requested a variance to build a 60 x 80 foot outbuilding with a 30 x 40 foot entertaining room on the front. The lot is 9.22 acres and the applicant is currently building a house on the lot.

The City of Elysian Zoning Ordinance allows an accessory building to be a maximum height of seventeen feet (17'), a maximum side wall height shall not exceed ten feet (10'), and total building area of 1,800 square feet per lot. The proposed Henninger outbuilding will be twenty-six (26') high with a side wall height of sixteen feet (16') and a total building area of 6,000 square feet.

The Elysian Planning and Zoning Commission held a public hearing on December 4, 2018 and on January 15, 2019. There were several neighboring property owners in attendance at the December 2018 public hearing who objected to the size, appearance and location of the outbuilding. They were concerned that the building would have a commercial use. The issue was tabled to the January 2019 public hearing with the request that Henninger consider the objections and come back with some possible compromise.

At the January 15, 2019 Planning and Zoning Meeting Henninger proposed to move the shed to the south east corner of the lot. The size and exterior of the shed will remain the same. The Planning and Zoning Commission voted unanimously to recommend approval of the variance request for the shed as presented with it being located in the southeast corner of the lot.

Mayor McBroom introduced the resolution and was seconded by Councilmember Opsahl.

A RESOLUTION ADOPTING FINDINGS OF FACT AND REASONS FOR APPROVAL FOR VARIANCE APPLICATION OF JEREMY HENNINGER, 182 RIDGE ROAD NE

FACTS

- 1. Jeremy Henninger is the owner of a parcel of land located at 182 Ridge Road NE, Elysian, Minnesota; and,
- 2. The subject property is legally described as found on Exhibit A; and,
- 3. Jeremy Henninger has applied to the City for a variance to build a 60 x 80 foot outbuilding with a 30 x 40 foot entertaining room on the front, and
- 4. The proposal would vary from the City of Elysian Zoning Ordinance Subd. Q. Accessory Structure Standards, 4. Dimensional Limits: Attached and detached accessory structures are subject to the dimensional limits established below:
 - a. Maximum height: seventeen feet (17') and a maximum side wall height of a detached structure shall not exceed ten feet (10');
 - b. Total number of detached accessory buildings per lot:
 - c. Accessory structure(s) total building area allowed per lot: 1,800 square feet.

In that it would be twenty-six feet (26') high with a side wall height of 16 feet (16') and the total building area would be 6,000 square feet.

- 5. Following a public hearing on the application, the Elysian Planning Commission has recommended approval of the variance on January 15, 2019.
- 6. The City Council of the City of Elysian reviewed the requested variance at its Meeting of February 11, 2019.

APPLICABLE LAW

- 7. Minnesota Statute Section 462.357, subd. 6 provides:
 - a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
 - b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

CONCLUSIONS OF LAW

- 8. The property owner does propose to use the property in a reasonable manner because the property is 9.2 acres, and in a rural type setting with low density housing abutting up to it. A building that size is less than 3% of the property and would be considered reasonable.
- 9. There are unique circumstances to the property not created by the landowner because the property is unique in size and setting. Even though it sits in the City, it is in a rural type setting with seasonal cabins abutting up to it and with wildlife running through it. By building one simple outbuilding instead of multiple high density 2 or 4 plex's, he is unique in leaving some of the rural tranquil setting within the City limits.

10. The variance will maintain the essential character of the locality because the shed will match the home. The land currently has a wilderness look and being 9.2 acres the essential character it will still be kind of a wilderness look. He is tucking the shed into the berm and using the topography of the land. He has moved the shed so it will be obscured and will not obstruct the neighboring property owners view of the sunsets. You are keeping more of a rural look with having only two buildings on the lot than having the townhomes.

NOW THEREFORE, BE IT RESOLVED by the City Council for the City of Elysian, Minnesota, that the application to issue a variance for Jeremy Henninger for the property located at 182 Ridge Road NE, legally described as: "Exhibit A", Le Sueur County, Minnesota, shall be, and is hereby approved to allow a variance to build a 60 x 80 foot outbuilding with a 30 x 40 foot entertaining room on the front as to deviate from the City of Elysian Zoning Ordinance Subd. Q. Accessory Structure Standards, 4. Dimensional Limits.

Beginning at the most westerly corner of Common Interest Community Number 026, Lakeview Manor Town Homes, according to the plot thereof on file and of record with the LeSueur County Recorder, said point being on the center line of County Highway No. 11; thence North 41 degrees 21 minutes 12 seconds East, (assumed bearing), along the northerly line of said Common Interest Community Number 026, a distance of 298.91 feet; thence North 89 degrees 16 minutes 35 seconds East, along said northerly line, 93.01 feet; thence North 82 degrees 36 minutes 00 seconds East, along said northerly line, 266.07 feet to the point of intersection with the southwesterly line of the plat of Franklin Subdivision, on file and of record with the LeSueur County Recorder; thence North 30 degrees 37 minutes 11 seconds West, along said southwesterly line, 59.06 feet; thence North 45 degrees 37 minutes 11 seconds West, along said southwesterly line, 600.12 feet; thence North 82 degrees 37 minutes 11 seconds West, along said southwesterly line, 600.12 feet; thence South 32 degrees 22 minutes 45 seconds East, 992.51 feet to the point of beginning.

Said parcel contains 9.22 acres, subject to an easement for County Road No. 11 purposes over and across the southwesterly boundary. ALSO subject to any other easements of record.

Public Works Worker Don Doehling reported he, Councilmember Suemnick, Public Works Director Ron Greenwald, and Crysteel Truck Representative Josh Miller had met and gone over the options for the quote of the equipment on the new plow truck.

On motion by Opsahl, seconded by Houlihan, all voting in favor, to accept the quote from Crysteel Truck Equipment for Cooperative Purchase of Equipment from State of Minnesota Bid (11' Tipper Box and Hoist Package, PTO Hydraulics, Trailer Hitch, Tool Box, Boss 10' DXT Snow Plow) in the amount of \$37,302.93 with a trade in value of used 2006 One Ton Chassis with Equipment in the amount of \$10,500.00 for a total after trade allowance in the amount of \$26,802.93.

McBroom opened the bids received for the lease of approximately 12 acres of tillable land (Parcel ID# 16.999.0310, ID# 16.999.0300, and ID# 16.999.0490) for a term of three years ending December 31, 2021.

1. Remove: Agenda Item 8. Waseca Area Hockey Association request for Charitable Gambling at Tuckers Tavern. (Gambling Manager Lynch requested to be removed from agenda)

Le Sueur County Sheriff Brett Mason reported construction of the new Justice Center is on time and under budget with the Certificate of Occupancy expected by the end of June and plans for the building to be open in September. Special efforts are being made to make the switch to the new building without any interruption in phone calls / dispatch especially 911. Sheriff Mason was asked to address when the signs marking the area where the truck fell through on Lake Francis will be removed, the speed limit on County Road 14 going east out of Elysian and having more patrol on State Highway 60 during peak times of 7:00 to 8:00 am and 4:30 to 5:30 pm. Mason was also asked to schedule the speed trailer for placement on State Highway 60. Mason stated there are new faces at the Sheriff's Department including dispatch, jailers, and new Deputy Ryan Frederick.

Public Comment: None.

Craig Beckman, 4C Supervisor - Division of Park and Trails, and Kent Skaar, State Trail Development, both of the Minnesota Department of Natural Resources (MN DNR), thanked the Council for allowing the MN DNR participation with the 2018 Street and Utility Project resulting in trail realignment. Skaar also confirmed that the trail reconstruction through Elysian will be finalized this year.

Beckman provided an Elysian Wayside Building Fact Sheet that reported the annual cost to operate the building is \$11,209. He explained that the wayside rest building located on Main Street and Third Street SW is unique and has a low priority for MN DNR funding. The majority of state trailheads include a picnic table, signage, and porta toilets.

Skaar stated the MN DNR looks across the state at all the buildings and reviews every structure. They really don't operate any fully flush facilities – most are stand alone porta toilets. So, the question is how the City and the MN DNR will move forward with this wayside rest building.

Beckman reported the building is in good condition. Items needing attention would be the insulation and cosmetic fixes such as upgrades to the countertops, toilets, and stall dividers. The building appears to be structurally sound. The City may want to have their building inspector look at the structure to see what updates will be necessary in the short, mid and long term. It was noted that

discussion or any agreement made in regard to the wayside rest building would be separate from the trailhead and the parking lot.

The Council expressed interest in keeping the wayside rest building operational. More discussion will be held at a work session meeting.

Kent Skaar then discussed the MN DNR trail right-of-way between Main Street East and State Highway 60 that is currently being utilized as a City alley and contains encroachment of several private owners. That property has now been surveyed and the MN DNR may be amicable to discussions of transferring that property to the City. If the Council is interested in acquiring the property, the first step would be to draft a letter to Beckman from the Council expressing interest in the City acquiring the alleyway (the property that includes the alley and the property to the north). Skaar did not know what the associated costs of that acquisition may be.

Public Works Director Greenwald presented the quote from Midway Ford Commercial for the 2019 F-550 4x4 Truck cab and chassis in the amount of \$57,473.01.

The Council then considered Resolution No. 663/19 approving an Interim Use Permit for Kristine L Miller, 205 Main Street East, to allow the property to be used for a General Residential R-1 permitted use (residence) while located in the Central Business Commercial C-1 District.

Kris Miller owns the property at 205 Main Street East. The Fitness Center and the house where she resides are located side by side on this property. Miller has had the entire property for sale for quite some time now and she has been unable to sell it. Miller is no longer interested in operating the Fitness Center and is at the point that she is going to close the Center and rent the property for another use. The community would like to see the Center stay open. It is an asset to the City of Elysian.

Brandi Rossow, rents space in the Fitness Center building and operates a Therapeutic Massage and Wellness business from the site. Rossow is interested in buying the Fitness Center building and keeping her business and the Fitness Center portion open. Miller and Rossow have been looking for a way to make this happen.

The property at 205 Main Street East is one parcel with two buildings on it. In order to sell the Fitness Center, separate from the house, there would have to be a parcel split. The parcel is zoned commercial. In order for the house to be allowed to continue to be used as a residence once it is split from the business, an interim permit would need to be issued.

The Planning and Zoning Commission met on April 2, 2019 and considered the application for an interim permit. They are recommending approval of the interim permit based on the following conditions:

- The lots be split and recordable deeds with updated legal descriptions be filed with Le Sueur County; and
- A shared water agreement be recorded with Le Sueur County and that both parties agree to hook up to water correctly on Main Street East at such time as Main Street is reconstructed. Said shared water agreement shall be prepared and presented to the City within the next sixty (60) days for pre-approval before the same is recorded; and
- 3. An easement shall be recorded on the Fitness Center property for the sewer main that runs on the west side of the property. Said easement shall be presented to the City within the next sixty (60) days for pre-approval before the same is recorded; and

- 4. That the Fitness Center hook up their own individual line to the sewer main within the next ninety (90) days. Said connection shall be built and installed pursuant to City standards and with City approval; and
- 5. That the interim permit being approved for 205 Main Street East to be used as a residence in a Central Business Commercial C-1 District shall terminate at such time as the current owner, Kris Miller, sells the property.

The Elysian Economic Development Authority also sees the Fitness Center as an asset to the community. They approved a request from Rossow at their April 4, 2019 meeting for assistance with the water / sewer costs and also a revolving loan for gap funding and upgrades to existing equipment and purchase of additional equipment.

Public Works Director Greenwald explained the water lines are still being chlorinated to clear up any bacteria residue. The Minnesota Department of Health will be testing the water again and if the water tests clear the chlorination will be discontinued. In the meantime, the Minnesota Department of Health is also requesting that the City resume the fluoridation of the drinking water. ELYSIAN RESERVE FIREFIGHTER POLICY

Reserve Firefighter Members

- **A.** Definition: Reserve Firefighters are defined as individuals who have previously served as and have been trained as full-time or volunteer firefighters and are no longer employed or working for another fire department.
- **B.** Requirements:

The Elysian City Council met in regular session on Monday, May 13, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers, Mary Opsahl, Dennis Schnoor, Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald; City Attorney Jason Moran. Absent: Councilmember Bobby Houlihan.

On motion by McBroom, seconded by Schnoor, all voting in favor, to approve the minutes of the April 8, 2019 Special Meeting and the April 8, 2019 Regular Meeting as presented.

On motion by Opsahl, seconded by McBroom, all voting in favor, to approve the agenda of the May 13, 2019 Regular Meeting with the following additions:

- 1. Update on Watercraft Inspector
- 2. Cable and Telephone Company

Le Sueur County Chief Deputy Nick Greenig reported the County Engineer has not heard back from the MnDOT Regional Engineer regarding the speed limit on County Road 14. Greenig stated that work continues to establish a legitimate lake high water level to require a no wake posting on the county lakes. He will keep the Council updated on progress.

Public Comment: None.

Kayla Bronk, Abby Crosby, and Illyana Kelley, representing Fifth Grade Girl Scout Troop #44869, presented their Movie in the Park Event Proposal. The goal is to earn their Bronze Award by hosting a community building event. They hope to have the event around the 4th of July at the Elysian Baseball Field and show the movie "How to Train Your Dragon: The Hidden World". The event would be free to attend, and they would sell concessions such as bottled water and soda, candy and chips. They will also ask Alley Scoops to come and sell ice cream. The cost for hosting the event is \$677 – Movie Licensing Fee \$435, 300-inch outdoor projector screen \$178, and PVC pipe frame for projector screen \$64. The troop will be contacting local organizations and businesses to request donations. They asked the City Council to contribute toward the projector screen and the PVC pipe frame. It was noted that if the City co-sponsors the event, it will be covered under the City's liability insurance.

In response to Council questions, the girls stated the money raised selling concessions will be used to cover any costs not covered by donations and for their big trip to Georgia next summer. They will use flyers to advertise the event and in the case of inclement weather they will reschedule the event to a different date.

On motion by Opsahl, seconded by Suemnick, all voting in favor, to co-sponsor the Troop #44860 Movie in the Park Event and to provide \$350 in funding (\$178 toward the projector screen, \$64 toward the PVC pipe frame for the screen and \$108 toward the movie licensing fee).

Sharon Brandt, President, American Legion #311 Auxiliary, was present on behalf of the American Legion and the Auxiliary. She provided a diagram of a Veteran's Memorial which has been proposed to the City of Elysian Park Board to be erected at the Sunset Park. The Memorial would be 20 feet wide by 25 feet long. Vetter Stone drew the diagram and the Legion is hopeful they will

be providing some type of discount. The Memorial will contain benches and the American flag, the family flags of the American Legion, and the five military as well as the POW flag. It will start out modest with the bottom being filled with smaller river rock and pebbles. The Legion will sell pavers that can be bought in honor of loved ones and it is anticipated that it will fill quickly. There will be solar lighting with the anticipation of permanent lighting in the future as the park develops.

Brandt stated they would like to place this on the natural berm at the center point of Sunset Park. This location would provide an easy grade for the elderly. A crushed rock path would be installed with the anticipation of a paved pathway in the future. The Legion will be raising money and soliciting donations from Legion members and will also be looking and asking that the City look for grants to pay for the project.

With that, Brandt stated they would like to have the Memorial completed by Memorial Day 2020 and asked the Council for the permission to go ahead with the project.

Councilmember Schnoor reported that the Park Board would discourage the proposed location. The park is still in the design stage and if placed on the berm the Veteran's Memorial would be the main attraction of the park. The proposed location is a long distance for a handicapped or elderly person. The Park Board would prefer to place it off to the side and closer to the road.

Brandt stated the Legion and Auxiliary would like to see it on the berm as it would be more visible from the DNR trail. There is more potential for vandalism if it is closer to the road and the berm would then obliterate the view. If you go to other areas, the Veterans Memorials are the center attraction of the parks. Brandt asked if the trees would still be moved this year and if the City would be expending funds to improve Sunset Park in the near future.

Greenwald stated the trees would be moved into the park this year. Schnoor stated the City has a certain amount of dollars to spend each year and it is divided between all three parks as recommended by the Park Board and approved by the City Council.

There was Council consensus to have a Joint Meeting with the Park Board at Sunset Park on May 21, 2019 at 7:00 pm.

A survey of the DNR property between State Hwy 60 and the businesses on Main Street was discussed. The area is currently used as an alleyway. Several of the businesses are encroaching on the property. At the March Council meeting, representatives of the MN DNR asked the City's interest in acquiring that property. The first step in that process is for the City to send an inquiry to the DNR expressing interest in the property.

On motion by McBroom, seconded by Opsahl, all voting in favor, to authorize the City Administrator to send a letter to the MN DNR expressing the City's interest in acquiring the property located between State Hwy 60 and the businesses on Main Street.

Chris Cavett, SEH Engineering, discussed the storm sewer at the DNR culvert crossing located under State Hwy 60 east of Second Street SE. The water runs through a buried pipe, through a DNR historical limestone culvert and into a MnDOT culvert and discharges on the other side of State Hwy 60. This is a problem as there is no straight (flow) line. Two options were looked at in 2016: Plan A: Extend the pipe, bypass the limestone culvert and connect to the MnDOT culvert. The City would have to remove or bury the limestone culvert., or Plan B: Develop a small pond system in the low area of the back of the two properties. The benefit of Plan B is the installation of a smaller pipe to regulate and slow the flow of the water.

Cavett noted that with the MN DNR reconstruction of the trail and the upcoming MnDOT State Hwy 60 project, this is the time for the City to work with those entities to make an improvement. Resolution of this issue would provide a long-term benefit to the City and would benefit the water flowing into Lake Elysian. Cavett requested authorization to work with the involved entities to determine a mutually beneficial solution and come back to the Council with a scope of work. He anticipated this would be 10-20 hours of his services.

On motion by McBroom, seconded by Suemnick, all voting in favor, to authorize Chris Cavett, SEH Engineering, up to 20 hours to discuss with MnDOT and the MN DNR and to develop the best resolution for the storm water flow under State Hwy 60 east of Second Street SE.

Cavett reported the contractor is working on the punch list items of the 2018 Street and Utility Improvement Project. The paving is scheduled for the end of May – first of June. Completion of the project is scheduled for the end of June. Cavett stated he did not anticipate any issues.

Schnoor stated he was displeased with the saw and seal in the curbs. He also stated that he was concerned that with the raised iron there was no tack used on the edges.

Public Works Director Greenwald reported that the large pavilion at the Lake Francis Park needs painting. The small pavilion is not as bad, but the dugouts need some attention as well. He asked if a volunteer group could be asked to do the painting and also if the Council would like to change colors possibly to match the new concession stand. There was Council consensus to refer this item to the Park Board.

Greenwald presented a quote from Hawkins for a chemical pump in the amount of \$574.97. He requested approval for the purchase of two of these pumps so he can resume the fluoride treatment. Hawkins will install the pumps at no charge. There may be a small cost for connection to the main.

On motion by McBroom, seconded by Opsahl, all voting in favor, to approve the purchase of two (2) Stenner 10 gpd pumps in the amount of \$574.97 each from Hawkins.

Greenwald reported the MN DNR is requiring a specific seed mix to reseed the area disturbed due to the 2018 watermain break between Roots Beach and Shoreview Drive. He provided a quote from Shooting Star Native Seeds in the amount of \$135 per pound. Greenwald stated he will also have to add some blue grass seed for a cost of \$150.

The Council then considered quotes for sealcoating the streets included in the 2016 Street and Utility Improvement Project. Pearson Bros., Inc. provided a quote for traditional type seal coating in the amount of \$25,277.03. Bargen Incorporated provided a quote for a different type of seal coating called RePlay Procedure in the amount of #1: Rate .020 for \$29,500 and #2: Rate .025 for \$31,995.

Cavett explained the RePlay Procedure is a soy-based product that penetrates one (1) inch into the surface and fills the voids. Several cities are using this product and reporting success. One complaint is that when it is completely hardened you cannot see it on the surface. The street looks the same. There are no rocks used so it is a nice application. Cavett stated that initially he thought this was going to be a lot less expensive than the traditional seal coating, but it is not. Cavett felt more research needed to be done and as the cost was the same or even more than traditional seal coating, he would recommend the Council approve the quote from Pearson Bros., Inc. for the traditional seal coating.

Greenwald reported that the City of Elysian had been one of the first cities to test the RePlay. It was used in 2013 in the Sakatah Addition at the .020 rate. There are very few cracks and that has not been seal coated. It was also used on the bike trail there which is a very thin layer of bituminous and that has held up very well.

On motion by McBroom, seconded by Opsahl, all voting in favor, to approve the specifications and estimate for seal coating the streets included in the 2016 Street and Utility Improvement Project in the amount of \$25,277.03 to Pearson Bros., Inc.

Greenwald presented a list of streets that need immediate repair or repair within the next one to two years. Most of these streets are included in the next phase of street improvements but a timeline has not been determined for a future street project. The proposals to mill and overlay the streets included on the list were as follows: WW Blacktopping \$60,198 and Crane Creek Asphalt \$55,800. Crane Creek would do the mill and overlay when they were in town installing the second layer of asphalt for the 2018 Street and Utility Improvement Project.

The Council discussed the funds available and asked which streets were in the worst condition. Greenwald stated that G Avenue, Third Street SW, and Second Street NE needed immediate repair. From the quotes provided it appeared those three (3) streets would cost approximately \$27,306.

On motion by Schnoor, seconded by McBroom, all voting in favor, to accept the proposal from Crane Creek to provide an overlay to G Avenue, Second Street NE, and Third St SW and to discuss in work session how to proceed with the remaining streets on the list in need of repair.

On motion by Opsahl, seconded by McBroom, all voting in favor, to approve Allison Rients for hire as the 2019 temporary summer employee.

Reminder of Wine & Beer Tasting Event at the Thirsty Beaver Bar on May 16th from 6:00 to 8:00 pm. This is a fundraiser for the Elysian Area Chamber of Commerce and proceeds will go toward the 4th of July Celebration / Fireworks.

ELYSIAN CITY COUNCIL SPECIAL JOINT MEETING WITH ELYSIAN PARK BOARD MAY 21, 2019

The Elysian City Council met in special joint session with the Elysian Park Board on Tuesday, May 21, 2019 at City Hall at 7:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Bobby Houlihan, Dennis Schnoor, Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald. Absent: Councilmember Mary Opsahl.

Elysian Park Board Members present included President Dennis Schnoor; Vice President Robert Houlihan; Secretary Nicole Lamont; Kris Miller, Roger Quiram, Ron Greenwald.

Sharon Brandt, President, American Legion #311 Auxiliary, and Tom Neidick, Commander, American Legion Post #311, presented a proposal for a 20' by 25' Veterans Memorial to be built on the berm in the center of Sunset Park in Elysian. The Memorial would be the focal point of the park and would be up high enough that the flags would be visible from the school, the bike path and the neighborhood to the north. The base would be built with Vetter Stone and the center would start as pea rock. The Legion plans to sell pavers in memory of loved ones to replace the pea rock. The American Flag would be positioned at the northern most point. The Memorial would be lit with solar LED lighting with conduit installed in anticipation of electricity to the park in the future. The City is planning to move some native trees to the park this summer and the Legion anticipates some trees to be planted around the Memorial. The lighting and trees will help deter vandalism.

McBroom suggested that even with the Memorial being the focal point, this will still be Sunset Park. This will not be a Veterans Memorial Park. The Memorial will be one thing in the Park and the other suggested items can be built around it. Perhaps there can even be events held there on July 4th or Veteran's Day to honor those who serve. McBroom asked if the Memorial would be funded via donations.

Brandt stated the Memorial is expected to cost \$15,000 to \$20,000 and the Legion is planning to fund it through donations and possibly some grants.

Mack Evans, American Legion #311 member, asked everyone to find support for this proposal. He noted the memorials in Morristown, Medford, and the Rochester Soldier Field Memorial which was built with no taxpayer dollars. He stated that Elysian has guys that work with trees, cement and they are all willing to volunteer. They all really believe in this project. Evans spoke of his family's service and his own service in combat situations in Vietnam. These experiences will live with the veteran forever. He asked that there be support for this proposal. There will be no expense to the taxpayer.

McBroom stated this would be a good start for the City Park – not the end. It would draw attention to the park and more people would start to visit. McBroom acknowledged the two concept drawings of Sunset Park and that he would like to progress with those ideas once there was more backing and more funds available.

Houlihan stated that the park needs to start somewhere, and this seems to be a good way to start.

Schnoor spoke as President of the Park Board. He stated no one was against the Veterans Memorial. The Park Board had met with the Legion at the site and they just felt there may be a

better location for the Memorial. The Park Board doesn't know how the park will be developed yet. They do not want the Memorial in the center of the park and to be a focal point of the park.

Neidick stated the natural place for this Memorial is on the berm. There is lots of space left in the park.

Lamont asked if the Legion was going to help with a path to the Memorial. This location is quite a distance from the parking lot.

Brandt stated the Legion would install a crushed rock path to begin with. The berm is in the center, but the Memorial would be built on the north side of the berm. They had walked it and it is not a steep walk.

Quiram noted that the berm is large. The Memorial can still be the focal point if it is located off to the side.

Houlihan stated he did not mind the Memorial being the focal point of the park. This is still a fluid park. The ideas for the park might be built sometime in the future, but this Memorial could be built this year. This is such a good thing and the people will come to enjoy it.

Greenwald stated he had not been at the Park Board meeting where this was discussed but if he would have been there, he would have voted in favor of the location requested by the Legion. This will not change the use of the park. It will be difficult to bring the Memorial closer to the parking area as there is a drop off and extensive dirt work would be required. He suggested that if the requested location is an issue, the memorial could be slid just a hair to the east. He likes the idea of the flags up on the berm. The amphitheater is a great idea, but he is a realist and just not so sure that is going to happen. The Veterans Memorial is going to happen. This will get the park started and he feels the berm is a great location.

On motion by McBroom, seconded by Houlihan, all voting in favor, to approve the Veterans Memorial proposal from the American Legion Post #311 at the requested location at Sunset Park and to move forward with the process.

On motion by McBroom, seconded by Suemnick, all voting in favor, to adjourn the meeting at 7:25 pm.

Le Sueur County Chief Deputy Nick Greenig reported his office is working with the Elysian Chamber of Commerce to prepare for the 4th of July celebration. Greenig stated crime has been fairly quiet in the City.

Public Comment: None.

The Council considered Resolution No. 667/19 – Adopting Findings of Fact and Reasons for Approval of variance application of Marjorie Slingsby, 411 Sixth Street NW, to allow them to build the patio / deck of their new home ten (10) feet into the 75-foot OHW setback of Lake Francis. The Slingsbys have recently purchased the 3.7 acre property. The new home will meet all setback requirements and allowed lot coverage. The only encroachment will be the deck / patio.

There currently is a non-conforming cabin located on the property that is entirely within the 75 foot OHW setback. If approved, a condition of the variance is that the non-conforming cabin must be removed (town down) before occupancy of the new home is allowed.

Todd Piepho, Area Hydrologist, MN Department of Natural Resource, commented as follows: "It appears the site is going to become more compliant, no comments from me."

The Planning and Zoning Commission considered the request at their meeting on June 4, 2019 and recommended approval based on the following:

- The property owner does propose to use the property in a reasonable manner because the proposal will remove a completely non-compliant cabin which is located in the 75-foot OHW setback of Lake Francis. This will make the entire site more compliant.
- 2. There are unique circumstances to the property not created by the landowner because of the elevation and slope of this hillside. If the house were to be pulled back away from the lake it would change the slope which will affect the run-off to the lake itself as well as the run-off to the waterway located on the east side of the lot.
- 3. The variance will improve the essential character of the locality because the new home will be more modern, and the proposal will remove a non-conforming structure.
- 4. And with the following condition:

a. The existing cabin must be removed (torn down) before occupancy of the new home is allowed.

The Council considered Resolution No. 668/19 – Adopting Findings of Fact and Reasons for approval for variance application of Robert Anhorn, 405 First Street North, to allow them to remove the existing house which is non-conforming and build a new slightly larger house in the same location. The request also includes the addition of three (3) decks on the house and a deck on the shed, all of which are located within the required 75 foot OHW setback.

Mr. Anhorn has recently constructed what he has labeled as Phase 1 to the south of his existing house. This is a 24 x 30 foot garage with living quarters above. Phase 1 was slightly into the 75 foot OHW setback and was allowed as it was an addition to the existing house and met all the setback requirements. The Building Inspector and City staff understood that Phase 2 was only an addition to square off that building, but the applicant is proposing to remove the existing and build new.

The proposal including the decks is within the allowed 25% lot coverage. The building will be less than the allowed 30 foot height restriction.

There is a 10-foot sanitary sewer easement across the south of the lot that precludes the structures from being located further south on the lot.

Todd Piepho, Area Hydrologist, MN Department of Natural Resource, commented as follows: "As always the Department would not support adding additional non-conformities by issuing a variance.

Any new encroachment towards Lake Francis would not be supported, specifically in this case the deck being proposed ~6' from the water's edge. MN Rule 6120 prohibits placement of anything within 10" of the OHWL. I understand this is a tough site, but there are options to permit the building without creating additional encroachment towards the lake. Removing the deck on the north side of the house and planting a screening of trees could be a condition of the variance if approved to allow the building. This would limit encroachment towards the lake and screen the new structure that is being proposed within the 75' setback."

Larry Hohnstadt, owner of property located on County Road 11 and Frank Avenue NW, attended the Planning and Zoning Commission meeting and spoke against the issuance of the variance.

The Planning and Zoning Commission considered the request at their meeting on June 4, 2019 and recommended approval to allow them to remove the existing home and build a home in the same location which includes squaring off the foundation to the east and increasing the footprint by approximately 100 square feet based on the following:

- 1. The property owner does propose to use the property in a reasonable manner because it is reasonable to square the foundation off because if not, the addition will result in some very irregular shapes and will conform with Phase 1 building.
- 2. There are unique circumstances to the property not created by the landowner because the buildable area between the shoreline and the sewer easement on the south side is very shallow and this placement does the best to fit between those two limitations.
- The variance will maintain the essential character of the locality because it will be an improvement over the existing house structure and pulls together with the existing Phase 1 structure.
- 4. And with the following condition:
 - a. The homeowner will work with the Minnesota Department of Natural Resources to provide some type of screening on the north side of the proposed structure.

AND:

The Planning and Zoning Commission recommends denial of the four proposed decks on the property based on the following:

- The property owner does not propose to use the property in a reasonable manner because the north decks would actually move the property closer to the lake, the west deck is located within the required setback, and the east deck in within the 75-foot OHW setback.
- 2. There are not unique circumstances to the property not created by the landowner because the property is already grandfathered in as non-compliant and the additional decks would further increase the amount of non-compliance.
- 3. The variance will not maintain the essential character of the locality because there are no other decks built that close to the lake in this area.
- 4. The DNR has cited MN rule 6120 which prohibits placement of anything within 10-feet of the OHWL.

Mayor McBroom introduced the resolution and was seconded by Councilmember Suemnick.

G1. is hereby denied.

Bill Stangler, Chairman and Lois Mack, board member, Le Sueur County Historical Society updated the Council on the status of the buildings and the organization. Mack reported the Elysian Museum is intact. The work that was being done on the three floors is only partially complete. The building needs a big cleaning. There is a dehumidifier and one air conditioner working in the museum. The basement has black mold and rust. The main and upstairs floors are stable. The art room is full of what is left from the Cleveland museum.

Mack stated the Genealogy Building looks fine. The technology needs to be updated. There is a dehumidifier and an air conditioner working in the basement. The work being done in the basement is not complete. There is art stacked on the floor that is covered.

The Le Sueur Historical Society is still under the authority of the receiver. There is a meeting on June 13 at 10 am with the judge for an update. There is a membership and board meeting June 12 at 7 pm in Le Center.

Mack stated the goal is to have the Genealogy Building open for viewing during the 4th of July celebration.

Stangler reported the goal of this Board is transparency. They are learning much as they go with \$200,000 needed to complete the work at the Ottawa Church, the Le Sueur School building being sold and all items needing to be removed by July 1, and a house in Waterville that the Board is attempting to divest themselves of.

Stangler invited the Council and the public to call him or any board member with any questions of concerns.

Residents of the Kaplan / Cedar Point area were present to discuss the garbage service. The bituminous on their private road is not real thick and the road is narrow. They would prefer to stop the big garbage trucks driving on that road. They are looking for a company who would service them with a small truck or pick up but have not found one. They asked if the City would allow them to have a dumpster with a lock located centrally in the City that they could bring their garbage to until such time as a permanent solution is determined. There are fifteen properties with fourteen being charged for garbage service. Of the fourteen, four use a 95 gallon cart, two use a 65 gallon cart, and the remaining eight use the drive by (tag) service.

West Central has been contacted and they will bring in a dumpster with a lock to the City Shop. The charge to the individual resident would remain the same as they are currently paying. The resident at 1 Cedar Point Drive NW could roll his cart to County Road 16 for pick up.

On motion by McBroom, seconded by Schnoor, all voting in favor, to allow West Central to place a temporary garbage and recycling dumpster on City property next to the City shop for use by residents of Kaplan / Cedar Point until a permanent plan is in place for collection of their garbage.

Brad Zimbrich, Tuckers Tavern, asked the Council to approve the closing of Main Street from 2nd Street NE to 2nd Street NW on July 27, 2019. He is working with Kari Voss, Event Planner, to organize a fundraiser event - "# Fight Like Hell for Veterans". Zimbrich asked that the streets be closed, and this be made into a community event. He expects at least 500 motorcycles in town. There will be two bands – one in the day and one at night. The Army is providing a rock climbing wall and the Marine Corp is bringing a pull up bar. Eight fire departments have committed to a barrel

war. There will be bouncy houses, a car show, a bike show, and a car and bike poker run. The MN Pork Producers are donating and cooking 800 pork chops. The American Legion Auxiliaries from several communities are bringing salads and desserts. Zimbrich plans to have the parking lot enclosed and sell wristbands.

Moran stated the City would require proof of insurance, security and alcohol licensing before any approval could be considered. Zimbrich and Voss will work to get those items to the City.

Public Works Director Greenwald reported that on May 24, 2019, someone hit the welcome sign on the east end of town. The planter around the bottom of the sign is damaged. In looking at different options, the cheapest will be to rebuild the planter with 6x6s. It will be approximately \$600 for materials. The Sheriff has made a report and insurance has been notified.

Greenwald noted that the City has a new F550 pick up truck on order. A number of people have approached him about the possibility of purchasing the old F550. Greenwald asked if it would be possible to take bids on the truck rather than trading it in to the dealer.

On motion by McBroom, seconded by Houlihan, all voting in favor, to advertise the F550 for sale via sealed bids to be opened at the August 12, 2019 City Council Meeting with the vehicle being available after the new truck has been received.

Councilmember Schnoor stated he would like to see the "no parking" on the south side of G Avenue lifted or moved. Trostem's has a fifth wheel coming the 4th of July weekend and he parks there. Schnoor did not see why it needed to be no parking on both sides of the street. Staff noted there had been complaints of sight problems when coming down that hill and when turning to go up the hill. Also, there were issues when only one lane of traffic remained open due to parking on both sides of G Avenue.

On motion by McBroom, seconded by Suemnick, all voting in favor, to remove the no parking zone on the south side of G Avenue SE, to paint the curb in that area yellow for 10 feet from the intersection and to keep the no parking on the north side of G Avenue.

Commissioner Steve Rohlfing reported the Justice Center is 75% complete. The County will be doing crack filling and cleaning ditches. 48 miles of county roads will be seal coated. County road striping is almost complete. The County Commissioners approved an ordinance to regulate short term rentals that will go into effect on August 1, 2019. There will be a public hearing in July to consider the fee schedule for the ordinance. The Commissioners are still working on the broadband issue with 78% of the county being covered. The biggest concern is cost, and the commissioners are visiting with the townships to see if they are willing to contribute. The Historical Society will meet with the County Board next Tuesday. Ray's Lake Park will be receiving some non-invasive enhanced walking paths. And, County budget work will begin in August.

Councilmember Schnoor introduced the resolution and was seconded by Councilmember Suemnick.

ELYSIAN CITY COUNCIL WORKSHOP MEETING JUNE 24, 2019

The Elysian City Council held a workshop meeting on Monday, June 24, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Bobby Houlihan, Mary Opsahl, Dennis Schnoor; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald. Absent: Councilmember Bryan Suemnick.

Paul Madsen, All Traffic Solutions, presented two radar signs and explained the available features. The radar units measure speed and can display speed, lettering, can blink or strobe and can include a camera. If subscribing to the cloud-based software, the units can collect data, can be programmed remotely, and can send alerts. Madsen noted that MnDOT may have specific parameters for signs on State Highway 60. Council preferred the larger sign on a trailer. Staff will contact MnDOT and request the parameters and then contact Madsen for price quotes for allowed signs.

At the March City Council Meeting, Craig Beckman, Minnesota Department of Natural Resources (DNR) had presented the possibility of the City acquiring the bathroom building located at the Wayside Rest on State Highway 60. The Council discussed the benefits to the community and the possible costs associated with maintaining the building including the ADA accessibility issues. Staff was directed to contact Beckman at the DNR and let him know the City is interested but does not have funds available to maintain the building in this year's budget. Also, Beckman had mentioned the possibility of the DNR gifting the City the amount that it would cost to tear the building down. Staff should ask if that is still a possibility and what that amount would be.

Council discussed the necessity of a rental agreement for use of the new Park Concession Stand. Several examples were considered. Staff will present a draft for consideration at the next Council meeting. Items to include are deposit, cleaning, no glass, 21 years or older.

Greenwald presented a potential cost to review the City's water system and pressure issues at the north end of Roemhildts Addition. SEH has provided a potential cost estimate in the amount of \$7,500 for the North Side Water System Analysis and \$250K to \$500K for a booster station if needed. The Council has allocated some funds in the budget for this project the last two years. There was Council consensus to continue to budget for this item and do the study once the adequate funds have been set aside.

Greenwald presented the list of streets that need work. Third Street South, G Avenue, and Second Street NE have received an overlay. There are still a few streets that are in real bad shape. The Council expressed an interest in the cost of an overlay to those streets yet this year. Greenwald will provide a quote at the July Council Meeting.

Greenwald also mentioned that Main Street east of the Elysian Bank is getting bad. There may be County participation in repair of that street. Greenwald will check with Cavett and provide an update.

The Council discussed items they would like to see addressed in the next year budget to include Fire Relief Pension, update of streets, parks, electric.

Le Sueur County Chief Deputy Nick Greenig reported the no-wake restriction was placed on the area lakes due to the lakes being above or at the 2018 lake levels. The lake levels are monitored and compared to the 2016 and 2018 high levels. The County is still working on a no-wake ordinance, but these levels will be used until the ordinance is drafted and approved.

Greenig stated the 4th of July celebration went well. There were minimal issues.

Public Comment: None.

Public Works Director Greenwald presented a quote from Kibble Equipment for a 2018 John Deere Gator in the amount of \$7,895.00. The unit was used at the Mankato Air Show. It has 53 hours on it, but it is new with "full factory warranty". It is two-wheel drive with differential locking. The box is coated. It has a 1,000-pound payload. The unit would need a blinker package to conform to the City Ordinance. It would be useful for running to the park, reading lift stations, 4th of July celebration, and many other short trips.

The Elysian City Council met in regular session on Monday, August 12, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Bobby Houlihan, Mary Opsahl, Dennis Schnoor, Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald. Absent: Utility Clerk Nicole Lamont; City Attorney Jason Moran.

On motion by Schnoor, seconded by Houlihan, all voting in favor, to approve the minutes of the July 8, 2019 Regular Meeting and the July 29, 2019 Budget Workshop as presented.

On motion by Houlihan, seconded by McBroom, all voting in favor, to approve the agenda of the August 12, 2019 Regular Meeting as presented.

Public Comment:

Tess Koster, 113 Shoreview Drive, "I see you are talking about short term rentals today. I have retired from the family business car lot so my new income to take me to retirement age is vacation rentals. I have (5) in Fort Myers Beach, Florida (full-time) and (1) here in Elysian (very part-time). I feel like this is a tourist town and we want tourists to have a place to sleep, have a place to stay. And, being as this is my income. I mean if you went uptown and said as of January 1st we are not going to have any restaurants open anymore well then all those people are out a job, I am out of a job and now you have tourists that have no where to eat and no where to sleep. So, I just really think you should consider maybe regulating the vacation rentals maybe instead of saying no we are not going to have that anymore."

Mayor McBroom noted that this will be discussed later on the agenda. The City does not want to stop VRBOs. They simply would like an ordinance in place that is beneficial to all involved parties.

Le Sueur County Chief Deputy Nick Greenig reported there have not been many issues within the City. The Justice Center Open House went well with over 700 in attendance. The Justice Center will be open for business September 3rd.

Greenig then discussed a proposal for the Le Sueur County Sheriff's Office to construct a firearms range to be located on the property of the City of Elysian's Wastewater Treatment Ponds Facility. The Le Sueur County Sheriff's Office Firearms Instructor and Greenig test fired multiple rounds at the proposed site and were unable to hear any muzzle blast at the nearest residential area of Osprey Way.

Houlihan stated he would like the noise to be checked again under various weather conditions.

Schnoor stated there should not be any shooting going on while the brush pile is open.

Greenig explained the firearms range would be used 8-12 times per year mainly during business hours. It would also be used approximately 2 times a year for night fire most likely in the winter from approximately 5:00 to 9:00 pm. The approximate dimensions of the range would be 40 yards in width and 100 yards in length. It would be 10-12 feet in height and eventually would be a "U" shape which would help suppress the noise as well. The County would provide fill saved from ditch projects to build the berm.

The Council was open to the request but would like Greenig to work with the City Attorney and staff to address issues such as insurance, noise, and effect on future development.

McBroom acknowledged the two bids received for the 2007 4-wheel drive Ford 550 truck. Bids were opened and the results are as follows:

Received August 8, 2019 10:00 am Ozzie Zrucky - \$11,550.55 Received August 9, 2019 3:30 pm Three Sixty Auto, Inc. - \$7,105.27

On motion by McBroom, seconded by Suemnick, all voting in favor, to award the bid for the 2007 4-wheel drive Ford 550 truck to Ozzie Zrucky in the amount of \$11,550.55.

The Council then considered Resolution #675/19 – Approving a Conditional Use Permit for Pete Johanson to construct a 5,904 square foot carpentry shop at 150 BlueBay Lane (PID 16.035.8000).

Johanson has purchased the property located on State Highway 60 between the Knotty Bar & Grill and BlueBay Lane. The property is zoned Highway Commercial C-2. This use would be allowed in the district as a conditional use.

Johanson provided a site plan, land survey, stormwater management plan, land use map, main floor plan, and shed elevations. All required setbacks are met. The City Engineer has reviewed the plans and approved the utility service connections, drainage / storm water management, and grading and erosion control. Mike Schultz, Le Sueur County Soil and Water Conservation District, has reviewed and approved the storm water management plan.

The Planning and Zoning Commission considered the request at their meeting on June 4, 2019 and questioned items such as number of employees, enclosure of the dumpster, number of parking spots, and blacktopping of the parking lot.

The Planning and Zoning Commission is recommending approval with the following conditions:

- 1. The parking lot will be paved bituminous within one year from date of approval of the conditional use permit.
- 2. That a minimum of (5) five mature evergreen trees be added to the maples screening the north and east of the property. The evergreens will be alternated with the maple trees with a minimum of (2) on the east side and (3) on the north side.
- The handicap parking spot be built to American Disabilities Act requirements.

Mayor McBroom introduced the resolution and was seconded by Councilmember Opsahl.

Part of the Southwest Quarter of the Southwest Quarter of Section 35, Township 109, Range 24, Le Sueur County, Minnesota, described as follows: Commencing at the northwest corner of said Southwest Quarter of Section 35; thence on an assumed bearing of South 00 degrees 00 minutes 00 seconds West along the West line of said Southwest Quarter 1241.39 feet to the point of beginning of the tract to be described; thence continuing South 00 degrees 00 minutes 00 seconds West along said West line 325.00 feet to the northerly right of way line of the now existing State Trail; thence South 85 degrees 04 minutes 00 seconds East along said northerly right of way line 215.54 feet; thence North 00 degrees 00 minutes 00 seconds East 325.00 feet; thence North 85 degrees 04 minutes 00 seconds West 215.54 feet to the point of beginning. This tract contains 1.60 acres of land and is subject to any and all easements of record.

The Planning and Zoning Commission has been discussing and monitoring short-term rentals (VRBOs) in the City for over a year. No steps had been taken as the Commission was waiting for Le Sueur County to finalize their ordinance regulating these properties and there had not been many complaints regarding the properties located in the City. The County has now adopted their ordinance and the number of VRBOs and complaints regarding VRBOs within City limits has increased dramatically over the past three months.

The Planning and Zoning Commission is recommending that a moratorium be placed on short-term rentals within City limits effective January 1, 2020 and that a working group be formed to include VRBO owners, concerned residents and Planning and Zoning representation, to discuss and investigate the issue and develop a fair and enforceable City ordinance to address this use.

On motion by McBroom, seconded by Houlihan, all voting in favor, to schedule a public hearing for September 9, 2019, to consider an ordinance to place a moratorium of up to one-year on short-term rentals including VRBOs within City limits. Council also approved a working group to discuss and investigate the issue and develop a fair and enforceable ordinance for this type of use within City limits.

The Planning and Zoning Commission is recommending a moratorium be placed on solar gardens for up to one-year to allow the Council to develop an ordinance to regulate their construction within City limits.

On motion by Houlihan, seconded by McBroom, all voting in favor, to schedule a public hearing for September 9, 2019, to consider an ordinance to place a moratorium of up to one-year on construction of solar gardens within City limits.

Wayne Murra, 14 Cedar Point Lane, stated the homeowners at Kaplan / Cedar Pont have not been able to locate a garbage company that is willing to bring a small pick up truck into their development to collect their garbage and recycle. The larger trucks are damaging their private drive. The City has allowed West Central to place a dumpster at the City Shop on a temporary basis for collection of the garbage, but the Public Works Department would like that removed before winter.

The Council discussed several options with Murra including a dumpster at the "t" in their development and a concrete pad at the intersection of Cedar Point Drive NW and County Road 16. Public Works Director Greenwald noted that the large heavy garbage trucks are damaging other streets in the City as well.

There was Council consensus to continue to collect the garbage at the City Shop on a temporary basis and to request that West Central provide smaller dumpsters to allow more room for snow

storage at the Shop as winter arrives. The Kaplan / Cedar Point Association will be meeting over Labor Day weekend to discuss options.

Public Works Director Greenwald presented two bids for an overlay to the severely damaged portions of Frank Avenue NE, Lake Avenue NE, Park Avenue NE, and First Street S. Seven streets had been named at the May 13, 2019 Council meeting and Council approved an overlay to three of those streets at that time. The named four streets remain in need of repair. Council directed Greenwald to obtain two more quotes and a special meeting will be called prior to the next Budget Workshop to discuss how to proceed.

Greenwald reported the Fire Department is selling a 14-foot Lund boat with a 35 hp engine and trailer for \$1,200. A boat is needed to put the buoys in and out of Lake Francis at the swimming beach. Staff is currently using the pontoon that is used in the wastewater treatment ponds. It is a lot of extra work to scrub that boat down and haul it over to the beach. Greenwald requested the Council consider purchasing the Fire Department boat.

On motion by Schnoor, seconded by McBroom, all voting in favor, to purchase the 14-foot Lund boat with 35 hp engine and trailer from the Fire Department in the amount of \$1,200.

Greenwald reported that since the construction in 2018, the water south of State Highway 60 has not passed the State of MN testing. The City has been chlorinating the water off and on since that time in an effort to get a consistent clear test. Greenwald recommended that the entire City drinking water be chlorinated at a low level permanently. The water at the source (well) is perfect. Every so often a foreign material can get in a line of the water system and chlorination will eliminate any worries of that.

Houlihan asked why not just do more flushing or change the location of the samples?

Greenwald stated that Elysian flushes their hydrants more than any other city in the State of Minnesota. Every hydrant is flushed once per month weather permitting. And he could move to a new location for sampling. It would require a series of on again off again chlorinating. But once it sits again, the water seems to pick up this color. It is not harmful, but it does need to be addressed.

Greenwald suggested a low rate of chlorine be added, .5 or .75 permanently. Then there won't be any issues. This will cost the budget approximately \$130 per month with an initial licensing fee of \$75. The City will also need to purchase a 55-gallon tank system. That cost has been anticipated and is included in the planning for next year's budget. This level of chlorine will not create a bad taste or odor. Greenwald noted chlorination has been a yearly State of Minnesota recommendation and he believes it is important. He strongly suggests the City chlorinate the water system permanently.

On motion by McBroom, seconded by Houlihan, all voting in favor, to chlorinate the water system at a low level permanently.

Chris Cavett, SEH Engineering, noted the Sanitary Service Extension Feasibility Report prepared by Wenck Engineering. Cavett and Jessica Hedin, SEH Wastewater Engineer have reviewed the report and believe it to be thorough, well written and understandable. The report addressed the ability of the existing City waste water facility to service the homes around Ray's Lake, the homes on Lake Francis directly west of City limits, the homes to the south of State Hwy 60 that are currently serviced by City water, and the homes on the west end of Sakatah Lake. The report found that the current system does not have the capacity to service all of these areas without an increase in the

wastewater facility. Basically, there is only enough capacity in the treatment facility to add less than 30 single family dwellings to the existing service area. This is in addition to the vacant undeveloped parcels within previously approved developments.

Cavett reported that he and Greenwald had met with representatives of MnDOT and DNR Trails to discuss the culvert and drainage off Main Street east of 2nd Avenue. The culvert goes under the trail, under the highway, to a ditch at Pit Stop and then into Lake Elysian. The current system is not good and there may be an opportunity for improvement when the DNR improves the trail.

One option is to install a new pipe under the trail and connect to the MnDOT culvert. MnDOT is not opposed to this idea. DNR has some issues with an existing "historic" limestone culvert.

An alternative is to consider formalizing a pond on the north side of the trail in the back of the adjacent properties. Flow would continue to drain through the existing DNR culvert unless the DNR and/or MnDOT were to consider installing new piping. This would be a long-term plan which would require applying for grant monies and working with the landowners.

Cavett left it with the Council for direction as to any further action.

Cavett then provided the Council with a photograph of a culvert washout on Lake Avenue NE near Third Street NE. The bank is steep and is going to continue to erode. Options for repair include installing rip rap on that slope or building a storm structure to slow the water and eliminate the erosion. Cavett stated this has probably been an issue for some time that has worsened with all the heavy rain. He will provide some options for repair at the September Council Meeting.

Cavett reported that on Second Street SE and the Sakatah Trail there is a spot in the newly constructed street that at times appears damp or wet and at other times goes away. This has been evaluated and tested over time and the conclusion is that the force main that comes from the lift station at the Pit Stop has a leak. This is a small leak that does not pose any health concerns. It appears the leak is close to where there are two 45 degree turns in the pipe. The biggest concern is that it is dug up in that area and that is not where the leak is located.

Options for repair include:

- 1. Open Cut Repair (would require excavating into the new street and hopefully finding the leak).
- 2. Pipe burst replacement of part of or all of the force main (would still require opening up the new street to provide an entry point).
- 3. Lining through a portion of the force main where the leak is believed to be (would allow for entry outside of the street).

James Bros. Construction has provided an estimate to open cut and repair the force main in the amount of \$8,880. This does not include the blacktopping.

Greenwald stated it has been leaking off and on for one month. He explained that the lift station has a 30-minute holding capacity so a pumping truck would be needed as well. That does not appear to be included in the estimate.

On motion by McBroom, seconded by Houlihan, all voting in favor, to proceed with the open cut force main repair with the estimate from James Bros. Construction, Inc. in the amount of \$8,880.

Cavett reported that four change orders for the 2018 Street and Utility Improvement Project were approved last year for work items that were not part of the original bid. The final quantities of that

work are not known, and the total contract amount will need to be reconciled with a final change order so the final payment can be released. The additional items were: Additional sidewalk on 3rd Street and Park Avenue; Additional trail work approved and paid for by the DNR and the additional parking lot quantities added at the Tourism Center.

Cavett reported that quality control testing during the bituminous wear course paving determined that the pavement met MnDOT specifications for acceptance, however, did not meet air void and density standards for full payment. This will cause the bituminous to be susceptible to weathering over time. MnDOT specifications call for a "Disincentive" based on the certified plant and American Engineering Testing's (AET's) test results. The total disincentive was calculated at \$12,244.91. Cavett recommended the City take the disincentive and sealcoat the bituminous this season or next season.

Cavett noted that sealcoating of the streets included in the 2018 project would have been recommended for 2020. However, given the situation and the available disincentive funds, it would be recommended that the City consider sealcoating the streets on this project in 2019 as an extra precaution. The cost will be added to the project costs and paid for mostly from the disincentive funds. There may be an advantage to wait until early 2020 to include the blacktop repair resulting from the force main leak repair. Cavett and Greenwald will monitor this and provide a quote as soon as it makes sense.

Cavett reported the 2018 Street and Utility Improvement Project contract is not finalized. There are still some turf areas that are disappointing. There is a pay item for weed control to be done early September and that has been successful with other projects.

Schnoor asked what would be done about the curb and gutter random cracking? Cavett stated there are a couple cracks that will be repaired this fall. He believes many of the cracks to be cosmetic rather than structural. Also, the turf is now established, and the wear course is down.

Schnoor stated that some of these cracks were identified before the wear course was down and nothing has been done. He reported there are 19 randoms in the curb on Third Street SE between Main Street and State Highway 60 and 10 randoms in Park Avenue NE between County Road 11 and 2nd Street NE. Cavett stated SEH will investigate.

Councilmember Schnoor introduced the resolution and was seconded by Councilmember Houlihan.

ELYSIAN CITY COUNCIL SPECIAL MEETING TO ADJOURN TO BUDGET WORKSHOP MEETING AUGUST 19, 2019

The Elysian City Council met in special session on Monday, August 19, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Robert Houlihan, Mary Opsahl, Dennis Schnoor and Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald. Absent: None.

The Council received and considered quotes for an overlay to a portion of Frank Avenue NE, Lake Avenue NE, Park Avenue NE, and First Street South. These are the four unrepaired streets of the seven streets named at the May 13, 2019 Council meeting as being in need of an overlay. The Council deliberated whether to repair these remaining streets in 2019 or wait until the Spring of 2020. As the cost in the Spring is estimated to be 25% less and the 2019 budget does not have funds to cover this expense, the Council decided to delay the repairs until the Spring of 2020.

The Council agreed they did not want the aforementioned streets cold patched unless absolutely necessary. Greenwald stated he would fill the holes that are down to Class 5.

On motion by McBroom, seconded by Suemnick, all voting in favor, to delay the overlay to a portion of Frank Avenue NE, Lake Avenue NE, Park Avenue NE, and First Street South until Spring of 2020 and to repair only the holes that are down to Class 5.

On motion by McBroom, seconded by Houlihan, all voting in favor, to adjourn to the Budget Workshop Meeting at 6:20 pm.

Councilmembers discussed the proposed 2020 budget expenses. Consideration was given to a request from Public Works Department for Emergency Situation Pay. This would be a change to the personnel policy that would provide a minimum of (2) two hours of pay at (1-1/2) one and a half the normal pay rate for a call back after regularly scheduled workday. Language on the proposed change will be considered at the next Council Meeting. Councilmembers also considered a pay rate increase request from the Public Works Director. Council consensus was that the proposed budgeted payroll amounts will remain as previously discussed with a 3% increase for all full-time employees.

The items discussed at the July 29, 2019 Budget Meeting have been incorporated and the proposed levy increase has been reduced from 8% to 5%. Council will present the current preliminary draft for approval at the September 9, 2019 City Council Meeting.

On motion by McBroom, seconded by Houlihan, all voting in favor, to close the Regular Meeting and open the Public Hearing at 6:00 pm.

The purpose of the Public Hearing is to allow public input from citizens on Ordinance #94/19 – An Ordinance Enacting a Code of Ordinances for the City of Elysian, Le Sueur County, State of Minnesota, Revising, Amending, Restating, Codifying and Compiling certain existing general ordinances of the Political Subdivision dealing with subject embraced in such Code of Ordinances, and Declaring an Emergency.

Kopischke stated this has been an ongoing process for over a year. The City contracted with American Legal Publishing to organize and group the City's existing ordinances, renumber and create a table of contents. The existing ordinances were also updated to reflect State Statute and be enforceable. There are some items that still need to be addressed and these issues will be looked at by Planning and Zoning and recommendations made to the Council. If approved, this will become the Code of Ordinances for the City of Elysian and will replace the current outdated ordinances. It will be easier to use and much more enforceable.

There were no public comments and no written comments have been received.

On motion by McBroom, seconded by Houlihan, all voting in favor, to close the Public Hearing at 6:03 pm and open the Regular Meeting.

Le Sueur County Sergeant Matt Shouler reported that it has been business as usual in the City of Elysian. He had no issues to report.

On motion by Schnoor, seconded by Houlihan, all voting in favor, to close the Regular Meeting and open the Public Hearing at 6:05 pm.

The purpose of the Public Hearing is to allow public input from citizens on Ordinance #92/19 – An Ordinance Ordering a Moratorium on Vacation Rentals by Owner within the City of Elysian, Minnesota.

Kopischke reported the Planning and Zoning Commission had been discussing the regulation of short-term rentals (VRBOs) in the City but there really weren't many complaints. This past summer a few more short-term rentals started operating and the City began to receive more complaints. Planning and Zoning is recommending approval of Ordinance #92/19 which would be effective January 1, 2020. They have also initiated a working group which includes VRBO owners, concerned citizens, and members of the Planning and Zoning to discuss the issue and develop an Ordinance that will be beneficial for all involved parties. The first meeting of that group was September 7. The next meeting is scheduled for September 28, 2019. It is hoped that an Ordinance can be developed and passed by the end of 2019. The reason for the moratorium is so that at that time, all short-term rentals will need

to cease and then come into compliance with the Ordinance. Then all will be operating under the same set of rules.

McBroom stated that the September 7 workshop was very productive. The group basically went through the Le Sueur County Ordinance and accepted some sections, questioned some and deleted others. The VRBO owners who attended the meeting had some good rules and information that included penalties for those who did not abide by the rules of the house.

Public Comments:

Bryan Paulsen, 121 Willow Point Drive, stated he is rather new on the lake. He has been here since April. He has been on some lakes that had VRBOs in his past and there have been some limitations on extension of time. He assumed that is one of the evaluations the City will be looking at – length of stay, things of that nature. Having been on the lake this summer, his observations were that the renters don't know boating laws and rules. Specifically, no lights on at night, drinking, partying. So, as the group evaluates these regulations, he is wondering if there is some way to verify if they are qualified boaters because he witnessed it multiple times. It is a very dangerous situation. They were really close to shore, sitting on his dock, no lights on. Very scary situation.

There were no further public comments. No written comments have been received.

On motion by McBroom, seconded by Schnoor, all voting in favor, to close the Public Hearing at 6:09 pm and open the Regular Meeting.

On motion by McBroom, seconded by Schnoor, all voting in favor, to approve the minutes of the August 12, 2019 Regular Meeting and the August 19, 2019 Special and Budget Workshop Meeting as presented.

On motion by McBroom, seconded by Schnoor, all voting in favor, to approve the agenda of the September 9, 2019 Regular Meeting with the following addition:

1. Minnesota Pump Works Quotes for ABS Pump at Lake Francis Lift Station #1

Public Comment: None.

The Council then considered Resolution #682/19 – Adopting Findings of Fact and Reasons for Approval for Variance Application of Ann and Tim Buskirk / Hobert Setzer, 127 Willow Point Drive.

The Buskirk's are requesting a variance to construct concrete sidewalks on the north and south side of their home and also a 15' by 23' concrete patio on the east (street) side of the home. The current lot coverage is 55%. The two sidewalks and patio would add an additional approximate 641 square feet of impervious surface which would result in 65% lot coverage.

The Buskirk's would like to add the sidewalks and patio to control the water on their property. The water runs down the hill north of their property and runs into the foundation on that side. It also runs toward the door on the east side and past the house and down the south side of the house. The concrete and installation of drains would be used to direct the water and move it to the lake and away from the foundation.

Todd Piepho, Area Hydrologist, Minnesota Department of Natural Resources, has commented as follows:

"My suggestion would be to strongly encourage them to install a berm/graded grassed waterway instead of a concrete chute to the lake. Without knowing all the details, it seems that grading a

waterway and seeding it down would address the problem without increasing impervious area on the lot. If the board decides to issue the variance maybe a raingarden could be added as a condition of the permit to allow for some settling of the water before it reaches the lake, at minimum maybe a native buffer planting at the base of the waterway to slow the flow and filter out debris. I understand the water is likely reaching the lake currently but slowing it down to allow for some settling would be a positive thing."

The Planning and Zoning Commission considered the request at their meeting on September 3, 2019. They did not believe there was enough area on the lot for a berm. They suggested Buskirk add rain gardens to filter the debris and sediment out of the water before it entered the lake.

The Planning and Zoning Commission is recommending approval of the variance based on the following findings of fact:

- Reasonableness: The installation of the concrete sidewalks and patio with drains and rain garden will divert the water away from the house and off the property. This system is needed to save the structure. Without this improvement the home and lot will be destroyed.
- Uniqueness: The amount of water being diverted onto this lot from the five properties above is unusual. There are also five properties below this lot that will receive the water if it is not managed.
- 3. Essential Character: The patio will line up the setback with the property next door. The walkways and patio will be poured concrete and grey in color. There will be landscaping, and this will be an improvement to the neighborhood.

And with the following condition:

1. That a new plan be submitted by Cory Atherton that shows the location and size of the drains and proposed rain garden.

Mayor McBroom introduced the resolution and was seconded by Councilmember Opsahl.

FACTS

- 1. Margaret J Setzer Trust (Ann Buskirk) is the owner of a parcel of land located at 127 Willow Point Drive, Elysian Minnesota; and,
- 2. The subject property is legally described as follows: The North Half of Lot 36, Block 2 of Chestnut's Lakeshore Subdivision, Le Sueur County, Minnesota, according to the plat thereof on file and of record in the office of the County Recorder in and for said County and State. Being part of Lot 5 of Section 34 and Lot 7 of Section 35, all in Township 109 North, Range 24 West, in said County and State. Subject to and with the benefits of the restrictions, provisions and conditions relating too the use of said property as the same are

- now filed and appear of record in the office of the County Recorder of Le Sueur County, Minnesota; and,
- 3. Ann and Tim Buskirk have applied to the City for a variance to construct concrete sidewalks on the north and south side of their lake home and also a 15' by 23' patio on the east side of the home.
- 4. The proposal would vary from the City of Elysian Zoning Ordinance Section 13.0 Shoreland Overlay Zone Subd. G1. as lot coverage by impervious surface will increase from 55% to 65%.
- 5. Following a public hearing on the application, the Elysian Planning and Zoning Commission has recommended approval of the variance on September 3, 2019.
- 6. The City Council of the City of Elysian reviewed the requested variance at its Meeting of September 9, 2019.

APPLICABLE LAW

- 7. Minnesota Statute Section 462.357, subd. 6 provides:
 - a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
 - b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

CONCLUSIONS OF LAW

- 8. The property owner does propose to use the property in a reasonable manner because the installation of the concrete sidewalks and patio with drains and rain garden will divert the water away from the house and off the property. This system is needed to save the structure. Without this improvement the home and lot will be destroyed.
- 9. There are unique circumstances to the property not created by the landowner because the amount of water being diverted onto this lot from the five properties above is unusual. There are also five properties below this lot that will receive the water if it is not managed.
- 10. The variance will improve the essential character of the locality because the patio will line up the setback with the property next door. The walkways and patio will be poured concrete and grey in color. There will be landscaping, and this will be an improvement to the neighborhood.
- 11. And with the following condition:

That a new plan be submitted by Cory Atherton that shows the location and size of drains and proposed rain garden.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ELYSIAN, MINNESOTA AS FOLLOWS:

The application to issue a variance to allow Ann and Tim Buskirk, 127 Willow Point Drive, to construct concrete sidewalks on the north and south side of their lake home and also a 15' by 23' patio on the east side of the home so as to deviate from the City of Elysian Zoning Ordinance Section 13.0 Shoreland Overlay Zone Subd. G1. is hereby approved.

AN ORDINANCE ENACTING A CODE OF ORDINANCES FOR THE CITY OF ELYSIAN, LE SUEUR COUNTY, STATE OF MINNESOTA, REVISING, AMENDING, RESTATING, CODIFYING AND COMPILING CERTAIN EXISTING GENERAL ORDINANCES OF THE POLITICAL SUBDIVISION DEALING WITH SUBJECTS EMBRACED IN SUCH CODE OF ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, the present general and permanent ordinances of the political subdivision are inadequately arranged and classified and are insufficient in form and substance for the complete preservation of the public peace, health, safety and general welfare of the municipality and for the proper conduct of its affairs; and

WHEREAS, the Acts of the Legislature of the State of Minnesota empower and authorize the political subdivision to revise, amend, restate, codify and compile any existing ordinances and all new ordinances not heretofore adopted or published and to incorporate such ordinances into one ordinance in book form; and

WHEREAS, the Legislative Authority of the Political Subdivision has authorized a general compilation, revision and codification of the ordinances of the Political Subdivision of a general and permanent nature and publication of such ordinance in book form; and

WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect at an early date.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF ELYSIAN:

Section 1. The general ordinances of the Political Subdivision as revised, amended, restated, codified, and compiled in book form are hereby adopted as and shall constitute the "Code of Ordinances of the City of Elysian, Le Sueur County, State of Minnesota."

Section 2. Such Code of Ordinances as adopted in Section 1 shall consist of the following Titles:

I: General Provisions

III: Administration

V: Public Works

VII: Traffic Code

IX: General Regulations XI: Business Regulations XIII: General Offenses

XV: Land Usage

- Section 3. All prior ordinances pertaining to the subjects treated in such Code of Ordinances shall be deemed repealed from and after the effective date of this ordinance except as they are included and reordained in whole or in part in such Code; provided, such repeal shall not affect any offense committed or penalty incurred or any right established prior to the effective date of this ordinance, nor shall such repeal affect the provisions of ordinances levying taxes, appropriating money, annexing or detaching territory, establishing franchises, or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing of money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plat or dedication of land to public use, vacating or setting the boundaries of streets or other public places; nor shall such repeal affect any other ordinance of a temporary or special nature or pertaining to subjects not contained in or covered by the Code.
- Section 4. Such Code shall be deemed published as of the day of its adoption and approval by the Legislative Authority and the Clerk of the Political Subdivision is hereby authorized and ordered to file a copy of such Code of Ordinances in the Office of the Clerk.
- Section 5. Such Code shall be in full force and effect as provided in Section 6, and such Code shall be presumptive evidence in all courts and places of the ordinance and all provisions, sections, penalties and regulations therein contained and of the date of passage, and that the same is properly signed, attested, recorded, and approved and that any public hearings and notices thereof as required by law have been given.
- Section 6. This ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality and shall take effect at the earliest date provided by law.

Kopischke reported that after the 2018 SUIP and the fence was installed around the lift station at the Lake Francis Park, issues with snow and drifting last winter, along with a new configuration in the park, it was apparent that a bigger gate on the south side of the fenced area would better serve public works needs and provide for lift station maintenance.

Caron Fence has provided a quote in the amount of \$1,458 to revise the fence and install a 16-foot gate on the south side of that area. Preliminarily it appears that the cost will be covered under the 2018 SUIP funding.

On motion by Opsahl, seconded by Houlihan, all voting in favor, to approve the proposal from Caron Fence LLC in the amount of \$1,458 to install (1) 16-foot-wide double drive Commercial Gate – Includes labor, equipment and material.

The overhead door operator on the building at the water treatment facility in not operational. Allied Overhead Door, Inc. has provided an estimate to replace the overhead door operator in the amount of \$1,100.

On motion by Schnoor, seconded by Opsahl, all voting in favor, to approve the estimate from Allied Overhead Door, Inc. in the amount of \$1,100 to replace the overhead door operator.

Request to hire Roger Quiram as an on-call part-time public works worker. On motion by Houlihan, seconded by McBroom, all voting in favor, to hire Roger Quiram as an on-call part-time public works worker at the rate of \$13.50 per hour pending background check.

Public Works Worker Doehling reported the pump at Lift Station #1 stopped working. There are two pumps at that station. Currently the lift station is operating with one new pump and the spare pump. Doehling presented two quotes from Minnesota Pump Works – one in the amount of \$5,688.98 to

repair the pump and one in the amount of \$9,616.72 to replace the pump with new. It was noted that the pump that stopped working is from the 1970s.

On motion by Houlihan, seconded by Schnoor, all voting in favor, to approve the quote from Minnesota Pump Works in the amount of \$9,616.72 to replace the pump in Lift Station #1 at Lake Francis Park.

Chris Cavett, SEH Engineering, presented Resolution #681/19 – Directing Modification of Existing Construction Contract 2018 Street and Utility Improvement Project to approve Change Orders 5, 6, 7, and 8. Approval of the four change orders will result in a contract increase of \$69,377.65. The revised contract amount is \$1,651,318.50.

Cavett explained the change orders as follows:

Change Order No 5: Extra grading work at the end of 2nd Street SE in the amount of \$1,500.

Change Order No 6: Cost to increase the perimeter length of the fence located around the park lift station in the amount of \$500.

Change Order No 7: Deduction change order for the bituminous disincentive payment in the deduction amount of -\$20,357.

Change Order No 8: Reconciliation Change Order of three paving items (DNR Trail, trail next to concession stand area in park, addition of Tourism Center parking, and pavement at Public Works Building) and one concrete sidewalk pay item (added sidewalk on 3rd Street and Park Avenue) in the amount of \$87,734.65.

The Council considered proposed language to update the Personnel Policy to address call-backs and City Attorney recommended changes to update the section in general. The Personnel Policy Section VII. Overtime would be updated as follows:

"Overtime and Compensatory Time

Upon vote being taken:

ATTEST:

The City of Elysian has established this overtime policy to comply with applicable state and federal laws governing accrual and use of overtime. It is recognized that in order to maintain basic services under unusual circumstances, emergencies, and peak workloads, employees may be required to work overtime.

The City Council will determine whether each employee is designated as "exempt" or "non-exempt" from earning overtime. An employee who works overtime without prior approval may be subject to disciplinary action. Only non-exempt employees are eligible for overtime.

At the beginning of each fiscal year, each department director will receive an allotted amount of evertime which may be used by their non-exempt employees. Overtime to be worked by an employee must first be approved by the Department Director City Administrator before it is incurred. Any anticipated evertime above the annual budgeted allowance must be approved in advance by the City Council before it is incurred. An employee called in for work at a time other than his/her normal scheduled shift will be compensated for a minimum of two (2) hours pay at one and one-half (1-1/2) times the employee's base pay rate. Extensions of shifts or early call-in of a normal shift will not be

considered call backs. Additional hours beyond the two (2) hours of call-in must be approved by the City Administrator or Mayor.

Overtime hours will be compensated at one and one-half (1-1/2) times the employee's regular rate of pay. At the mutual agreement of the employee and the supervisor, overtime may be compensated with compensatory time at one and one-half (1-1/2) times the overtime hours worked in lieu of overtime pay.

Compensatory time accrues at one and one-half (1-1/2) hours for each one (1) full hour of authorized overtime worked. No more than forty (40) hours of compensatory time may be accumulated at any time, unless authorization has been received by the City Council. An employee may roll over sixteen (16) hours of compensatory time into the next payroll year. Any compensatory time accumulated over the sixteen (16) hour maximum will be paid out monetarily on the last pay period of the payroll year.

Overtime earned will be paid at the rate of time and one-half on the next regularly scheduled payroll date, unless the employee indicates on his/her timesheet that the overtime earned is to be recorded as compensatory time in lieu of payment. All compensatory time will be marked as such on official timesheets, both when it is earned and when it is used.

All accrued compensatory time will be paid out to the employee at time of separation."

On motion by McBroom, seconded by Houlihan, all voting in favor, to accept the proposed language and update the Personnel Policy as presented.

A representative from LTD Broadband was present to introduce their products to the Council. He explained the services available and the equipment that is used. It would be necessary to install antennas on the water tower. The antennas are small. A small amount of electricity would also be necessary. LTD Broadband has offered to pay \$1,000 yearly rent to the City or to provide multiple City buildings with free high-speed internet service.

Council expressed interest in the service and asked the representative to forward a contract to the City Attorney for consideration.

Council considered Resolution #678/19 – Adopting the 2020 Proposed Budget. Council has held two workshops to discuss the 2020 proposed budget. Some key items in the budget include a 3% COLA for all full-time employees, the addition of a Presidential Primary which will result in three elections in 2020, increase in City Attorney hourly rate, savings toward generator for the City Hall building, and increase fire relief benefit by \$100 per service year. The Council will meet again to discuss the budget prior to approving the final 2020 Budget in December.

ELYSIAN CITY COUNCIL REGULAR MEETING OCTOBER 14, 2019

The Elysian City Council met in regular session on Monday, October 14, 2019 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Bobby Houlihan, Mary Opsahl, Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Worker Don Doehling; City Attorney Jason Moran. Absent: Councilmember Dennis Schnoor; Public Works Director Ron Greenwald.

Le Sueur County Chief Deputy Nick Greenig reported all has been quiet in the City. He had nothing to report.

On motion by Houlihan, seconded by McBroom, all voting in favor, to approve the minutes of the September 9, 2019 Regular Meeting as presented.

On motion by Houlihan, seconded by Opsahl, all voting in favor, to approve the agenda of the October 14, 2019 Regular Meeting as presented.

Public Comment: None.

The dumpsters at the City Shop for collection of Kaplan / Cedar Point garbage were discussed. The dumpsters had been allowed on a temporary basis. With winter approaching the Public Works Department would like them removed so that snow can be piled in that area. Wayne Murra, Richard Griffin and Tiffany Olson were present on behalf of Kaplan / Cedar Point. Several locations for a dumpster were considered including: the "t" in the Kaplan / Cedar Point development, the intersection of Cedar Point Drive NW and County Road 16, the County Park on Ray's Lake, the City Shop on 6th Street NW.

Murra stated the road in their development is constructed of three inch bituminous and cannot handle the large trucks. He has contacted numerous trash haulers and has been unable to locate a hauler with a small truck that will service 4-5 households. He asked if this was something the City could request at the time of renewal of contract with West Central Sanitation.

There was Council consensus to contact Le Sueur County to ask if locating a dumpster at the County Park would be an option. If not, the City Attorney will start an email chain with West Central to see if there is any possibility of getting a smaller truck to service the City.

Staff has contacted MnDOT to ask if directional signage to Lake Francis Park, Sunset Park and the Veterans Memorial could be installed on State Highway 60. Adam Schendel, Senior Engineering Specialist, has reported that Sunset Park and the Veterans Memorial do not qualify for directional signage at this time as they are both in the development phase. For the Lake Francis Park, three different sign designs were offered with costs as follows: Option #1 - \$1,836.50, #2 - \$2,490.00, and #3 - \$2,170.40. The cost would cover sign design, predetermined costs for fabrication and installation, infrastructure overhead, general maintenance and removal of the sign. The sign would be renewable in 15 years.

Council discussed and agreed this was not in the budget at this time. They will consider again when Sunset Park and the Veterans Memorial are eligible for the directional signage.

Craig Beckman, Minnesota Department of Natural Resources, has emailed to inquire if the following Deed Restriction would be acceptable to the City with regard to acquisition of the wayside rest building:

Deed Restriction:

The Grantee shall have the following conditions recorded with the deed to all lands within the park as described in Attachment ____ - Boundary Map and submit an attested copy of the deed and the condition to the State:

IN order to comply with the Department of Natural Resources Outdoor Recreation Project Contract <<Project Number>>, the <<Grantee>> does hereby impose the following restrictions on the property described in Attachment ____ - Boundary Map:

- This land was acquired by the State with assistance from the federal Land and Water Conservation Fund (LWCF) pursuant to P.L. 88-578 as codified in 54 U.S.C. Section 200305 and must be retained and operated solely for public outdoor recreation use as prescribed by 36 CFR Part 59. The grantee shall ensure the LWCF requirements are met into perpetuity or the land will revert to the State.
- 2. The grantee shall post no signs or information indicating this land is other than public land available for public outdoor recreation use.
- 3. The Grantor reserves the right to enter and inspect the property at any time to ensure the terms of this deed restriction are met.

Beckman states that the restrictions are required as the property was acquired with Land and Conservation Fund Dollars.

City Attorney Moran will contact Beckman to possibly refine the language and ensure that the City can demolish the building or other action they deem necessary in the future as long as the "property" remains available for public outdoor recreation use. He will also determine the DNR intent for the parking area.

Don Doehling, Public Works Worker, presented a quote from Minnesota Pump Works to replace the valve between sewer pond #2 and sewer pond #3 in the amount of \$4,657.50. Replacement of this valve is included in the budget.

The EDA has advertised the building in the City newsletter, Facebook and a large banner on the building. The building continues to deteriorate with the roof caving in. The neighboring property owner approached the EDA to complain of the shingles blowing onto her property and the water running under the building heaving

up the sidewalk between the buildings. The EDA is currently in the process of negotiations to demolish the building and sell the property to the adjoining property owner.

Kopischke reported the VRBO Working Groups consisting of VRBO owners, concerned citizens, and Planning and Zoning Commission members has met three times. They had discussed rules and regulations and penalties, fines and revocation and presented their recommendations. This information has been given to the City Attorney for the drafting on an ordinance which will be considered by the Planning and Zoning Commission at their November Meeting.

Public Comment: Judy Williams, 1642 Scenic Hideaway Lane NE, Elysian Township, stated she had read through the proposed Ordinance #95/19 and she did not believe it was correct to refer to the type of rental as "Vacation Rental by Owner – VRBO". She stated that "VRBO" is a specific marketing website that lists rental properties that owners can subscribe to and advertise their properties. She thought the ordinance should refer to the rentals as "short term rentals" similar to Le Sueur County.

The Council considered Resolution #686/19 – Adopting Findings of Fact and Reasons for Approval for Variance Application of Bruce and Barb Starke, 504 Lake Avenue NW. The Starkes have requested a variance to demo their existing cabin and rebuild a two-story home within the same footprint on their property. The current building and the proposed new home will be 28 feet by 16 feet. The difference being that the new home will have a second story.

This property is located in the shoreland of Lake Francis. The property is 200 feet deep by 50 feet wide or 10,000 square feet. So, this is a non-conforming lot in the shoreland zone. The deed states that the owners each have a 1/3 interest in this parcel. There are no specific lot lines for each home as all three homes are on one lot. There is no way to evaluate lot coverage or setback.

A variance is required from the following requirements of the Zoning Ordinance:

- Construction on Non-Conforming Lots of Record
 - a. In shoreland, a nonconforming single lot of record may be allowed as a building site without variances from lot size requirements, provided that:
 - i. All structure setback distances can be met; and
 - ii. The impervious surface coverage does not exceed 25% of the lot.
 - b. A variance from setback requirements must be obtained before any use or building permit is issued for a lot. In evaluating the variance, the board of adjustment shall consider constraints of the lot and shall deny the variance if warranted.

The City Attorney has been consulted and he has advised, "...In sum, because each owns 1/3 interest in the same lot, we cannot establish lot lines and setbacks, so a variance is technically,

under the letter of the Zoning Code, needed. If you find that they meet the practical difficulties test, then a variance should be issued..."

The Planning and Zoning Commission is recommending approval of the variance request based on the following:

- Reasonableness: This proposal will retain the same footprint as the existing cabin. The new structure will not obstruct any property's view of the lake and will provide a modernized building.
- 2. Uniqueness: The lot is unique in that the legal description grants each owner 1/3 interest in the lot. There are no clear lot lines delineated on the survey.
- 3. Essential character: This will improve the essential character of the locality as a new more modernized structure will fit in with other cabins and homes in the area.

Opsahl asked why the property owners would just not divide this into three lots? Attorney Moran stated it certainly could be done that way.

FACTS

- 1. Bruce and Barbara Starke are the owners of a parcel of land located at 504 Lake Avenue NW (PID# 16.410.0200), Elysian Minnesota; and,
- 2. The subject property is legally described as follows: Lot 8, Block 4, City of Elysian, formerly called the Old Townsite of Elysium, according to the Amended Plat and Resurvey thereof, on file and recorded in the Office of the County Recorder in and for Le Sueur County, Minnesota; and,
- 3. Bruce and Barbara Starke have applied to the City for a variance to demolish their current cabin and rebuild a two-story home in the same footprint on their property which is a non-conforming lot.
- 4. The proposal would vary from the City of Elysian Zoning Ordinance Section 14.0 Nonconformities Subd. 1b. and c. as this is a non-conforming lot with their ownership described as 1/3 interest in the lot and there is no means to determine the setbacks or the lot coverage.
- 5. Following a public hearing on the application, the Elysian Planning and Zoning Commission has recommended approval of the variance on November 5, 2019.
- 6. The City Council of the City of Elysian reviewed the requested variance at its Meeting of November 12, 2019.

APPLICABLE LAW

7. Minnesota Statute Section 462.357, subd. 6 provides:

- a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
- b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

CONCLUSIONS OF LAW

- 8. The property owner does propose to use the property in a reasonable manner as the proposal will retain the same footprint as the existing cabin. The new structure will not obstruct any property's view of the lake and will provide a modernized building.
- 9. There are unique circumstances to the property not created by the landowner in that the legal description grants each owner 1/3 interest in the lot. There are no clear lot lines delineated on the survey.
- 10. The variance will improve the essential character of the locality as a new and more modernized structure will fit in with the other cabins and homes in the area.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ELYSIAN, MINNESOTA AS FOLLOWS:

11. The application to issue a variance to allow Bruce and Barbara Starke, 504 Lake Avenue NW, to demolish their current cabin and rebuild a two-story home in the same footprint on their property which is a non-conforming lot so as to deviate from the City of Elysian Zoning Ordinance Section 14.0 Nonconformities Subd. 1b. and c. is hereby approved.

Schnoor stated the Ordinance seem restrictive, specifically B4. McBroom explained that some of the restrictions on parking, etc. are meant to help limit the amount of people at the rental which will in turn control the amount of noise and other issues related to complaints.

Ron Greenwald, Public Works Director, presented the Wastewater Compliance Evaluation Inspection Report that resulted from an inspection of the Elysian WWTP on September 27, 2019 by Teri Roth and Cara Omana of the Minnesota Pollution Control Agency (MPCA).

Greenwald discussed all compliant and non-compliant items listed in the Report. All non-compliant issues need to be addressed and resolved within 30 days of the report which is dated October 25, 2019. Council discussed the need to release the wastewater as the higher level may have an adverse effect on the integrity of the ponds, the importance of notifying the duty officer of any release immediately, and the reporting requirements. Greenwald stated all required follow-up will be completed as requested.

The main area of increase is in the general fund levy which increased by \$34,922. 2020 Budget Expenditures are \$1,507,929 up from \$1,302,219 in 2019. 2020 Budget Revenues are \$1,480,218 up from \$1,368,693 in 2019. The Council will be looking at water and sewer rates at the 2019 year end meeting and other revenue will be transferred from savings to make up the difference between expenses and revenue. Increases to the 2020 budget include: health insurance costs, 3% COLA increase employee compensation, increase in attorney hourly rate, increase in Fire Relief Annual Benefit Level from \$1,300 to \$1,400, and three elections in 2020.

Kopischke stated that most homeowners will not see an increase in the City portion of property taxes due to the growth in the City over the past two years.

There were no public comments and no written comments have been received.

On motion by McBroom, seconded by Schnoor, all voting in favor, to close the Public Hearing at 6:06 pm and open the Regular Meeting.

Public Comment: None.

The Council considered Resolution #689/19 – Adopting Findings of Fact and Reasons for Denial of Variance Application of Ron Romnes, 708 Lakeside Drive NW. Mr. Romnes has requested a variance to build a 64 foot by 36 foot accessory building (as revised from the originally requested 72 foot by 40 foot accessory building) on his lot.

The accessory building would be 2,304 square feet. It would be placed on the southern portion of the lot away from Lake Francis and not located in the 75 foot OHW mark. It would meet all setback

requirements and the resulting lot coverage would be 11%. However, the shed is larger than the allowed 1,800 square feet and the sidewalls are taller than the allowed 10 foot sidewalls.

The Planning and Zoning Commissioners liked the look of the shed and agreed that it fit on the lot, but the request did not meet the Practical Difficulty Question #2 Uniqueness Requirement – that the landowner's problem is due to circumstances unique to the property not caused by the landowner. The uniqueness was not due to the physical characteristics of the land but to the personal preference of the landowner.

The Planning and Zoning Commissioners discussed the possibility of the City Council amending the zoning ordinance to allow a larger sized accessory building within City limits. There would need to be a new maximum size and conditions that would regulate the lot coverage and that it meets the required setbacks. This seems to be a natural progression as people have more "stuff" now. Allowing a larger shed where it met the requirements would help to beautify the City as personal property would be stored inside sheds rather than being an eyesore in the yards.

Planning and Zoning Commissioners voted unanimously to recommend City Council deny the request of Ron Romnes, 708 Lakeside Drive, for a variance to build a 64 foot by 36 foot accessory building on this lot as it does not meet the Practical Difficulty Factor #2 Uniqueness required to grant a variance request. They also voted unanimously to recommend the City Council refer to the Planning and Zoning Commission to study amending the zoning ordinance to increase the allowable maximum accessory building size subject to adherence to the required setbacks and that it results in less than 25% lot coverage.

Mayor McBroom presented the resolution and was seconded by Councilmember Schnoor.

FACTS

- 1. Ron Romnes is the owner of a parcel of land located at 708 Lakeside Drive NW, Elysian, Minnesota (PID # 16.460.0070); and,
- 2. The subject property is legally described as found on Exhibit A; and,
- 3. Ron Romnes has applied to the City for a variance to build a 64 foot by 36 foot accessory building (as revised from a 72 foot by 40 foot accessory building) on the lot.
- 4. The proposal would vary from City of Elysian Zoning Ordinance Section 15.0 Performance Standards Subd. Q. Accessory Structure Standards 4 a. Maximum height: Seventeen feet (17') and a maximum side wall height of a ten feet (10') and c. Total building area allowed per lot: 1,800 square feet in that it would have a side wall height of 12 feet six inches (12'6") and be 2,304 square feet.
- 5. Following a public hearing on the application, the City of Elysian Planning and Zoning Commission has recommended denial of the variance on December 3, 2019.

6. The City Council of the City of Elysian reviewed the requested variance at its Meeting of December 9, 2019.

APPLICABLE LAW

- 7. Minnesota Statute Section 462.357, subd. 6 provides:
 - a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
 - b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

CONCLUSIONS OF LAW

8. There are not unique circumstances to the property not created by the landowner because an 1,800 square foot accessory building would fit on the property. There are no issues with the property that would preclude an 1,800 square foot accessory building to be located on the lot. The uniqueness does not relate to the physical characteristics of the property (the land) but does in fact only result from the personal preferences of the landowner.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elysian, Minnesota, that the application to issue a variance to allow Ron Romnes, 702 Lakeside Drive NW to build a 64 foot by 36 foot accessory building so as to deviate from City of Elysian Zoning Ordinance Section 15.0 Performance Standards Subd. Q. Accessory Structure Standards 4 a. Maximum height: Seventeen feet (17') and a maximum side wall height of ten feet (10') and c. Total building area allowed per lot: 1,800 square feet is hereby Denied.

On motion by McBroom, seconded by Schnoor, all voting in favor, to refer to the Planning and Zoning Commission to study amending the zoning ordinance to increase the allowable maximum

accessory building size subject to adherence to the required setbacks and that it results in less than 25% lot coverage.

On motion by McBroom, seconded by Opsahl, all voting in favor, to close the Regular Meeting and open the Public Hearing at 6:15 pm.

The purpose of the Public Hearing is to receive input on Ordinance No. 95/19: An Ordinance Regulating Short Term Rentals within the City of Elysian.

The purpose of this Ordinance is to allow and provide for the Licensing, Inspection, and Rental of Short Term Vacation Properties in the City of Elysian. Members of the Planning and Zoning Commission held three workshop sessions with owners of Short-term Rental properties currently operating in city limits and with concerned residents to determine reasonable parameters for the regulation of short-term rentals in the City. Examples of ordinances from Le Sueur County and other cities in Minnesota and Wisconsin were provided. The notes and comments from those workshops were then shared with the City Attorney who drafted the proposed version of the Ordinance.

Schnoor questioned Section (B)4. "Ice Houses, Fish Houses, Campers, Tents, Recreational Vehicles, All-Terrain-Vehicles, and Golf Carts must be placed in a designated parking spot. Such items cannot be parked in the yard on the grass. All must be parked on an impervious surface." He believed this item is too restrictive. He suggested that if someone went out on the lake and came back to have lunch and parked on the grass, theoretically, the way this is worded, a neighbor could report them to the sheriff for a violation of the ordinance.

McBroom explained that the item was basically included to address the trailers and limit the number of vehicles and trailers and in turn, to help limit the number of people at the property.

Councilmembers discussed and agreed that item (B)3 was sufficient to address this issue and that item (B)4. could be removed.

There were no public comments and no written comments have been received.

On motion by McBroom, seconded by Opsahl, all voting in favor, to close the Public Hearing at 6:22 pm and open the Regular Meeting.

Mayor McBroom introduced Ordinance #95/19 and was seconded by Councilmember Schnoor, all voting in favor:

CITY OF ELYSIAN LE SUEUR COUNTY, MINNESOTA SHORT TERM RENTAL ORDINANCE ORDINANCE NO. 95/19

- (A) Purpose. The purpose of this Ordinance is to allow and provide for the Licensing, Inspection, and Rental of Short Term Vacation Properties which consist of non-traditional lodging for over-night stays on a daily or weekly basis of thirty (30) days or less of a private single-family dwelling, cabin, or condominium which provides basic living accommodations including sleeping space, toilet, and cooking space. This does not include Bed and Breakfasts, Resorts, Campgrounds, or Hotels/Motels. Attached garages, and accessory structures including, but not limited to, boat houses, detached garages, sheds, and/or barns are not acceptable dwelling units.
- (B) Land Use Performance Standards/General Requirements and General Regulations.

- Maximum capacity. No more than three (3) occupants, excluding children under age three (3), per bedroom shall be allowed to stay on the property onsite overnight (overnight being defined from sunset to sunrise). During the daytime hours, as defined from sunrise to sunset, that maximum capacity shall be no more than 1.5 times the overnight capacity.
- 2. A maximum of one (1) rental unit per conforming dwelling lot of record. The one (1) rental unit allowed must be the primary structure associated with the lot in question and cannot be an outbuilding, camper, motor vehicle, recreational vehicle, guest house, guest cottage, or any other structure.
- 3. Onsite parking only. Parking must be in designated parking spaces only. This includes all motorized vehicles, fish houses, campers, and trailers. There shall be one (1) designated and dedicated parking space per bedroom. The number and location of parking spaces must be included and clearly defined and delineated on the Short Term Rental License Application. All parking spaces shall be a minimum of two hundred (200) square feet and be on an impervious surface.
- 4. Rentals of motorized watercraft and recreational vehicles are allowed if they display a valid permit issued by the Minnesota Department of Natural Resources.
- 5. Quiet Hours. Quiet Hours shall be from 10 PM to 7 AM. During this time, excessive or loud noise is prohibited. Excessive or loud noise shall be defined as unreasonably loud, boisterous, obscene, offensive, or abusive language or noise as heard from a neighboring property to the licensed property. It shall include, but not necessarily be limited to the following types of conduct: shouting, yelling, playing loud music, unreasonably loud conversation, or loud partying, all as heard from the neighboring property.
- 6. Property lines shall be clearly marked with the applicant submitting a map with clearly delineated property lines on the application.
- 7. Fireworks shall be prohibited.
- 8. Garbage and Garbage Removal. All garbage, refuse, or recycling shall be stored completely enclosed in designated garbage containers. The property shall be serviced for garbage removal by a professional removal company per the City's Ordinances. Per City Ordinance §153.19 garbage cans are also to be removed from the boulevards by the day following garbage pickup.
- 9. Campfires. All campfires shall be confined to a three (3) foot by three (3) foot maximum size. There shall be no unattended campfires. Campfires shall by in designated areas only.
- 10. Sewage.

- a. The property must have a fully operational and fully complaint subsurface sewage treatment system (SSTS) or be connected to municipal services.
- b. Holding tanks are prohibited.
- c. The property must follow and comply with Le Sueur County's compliance inspection time parameters.
- d. The system must be properly sized for proper use.
- e. The SSTS must be kept in a constant state of compliance and under a valid Operating Permit.
- 11. The discharge of firearms, including CO2, pellet, or BB guns, is prohibited.
- 12. Pets shall be attended to and leashed at all times.
- 13. All properties must be Registered and Licensed by the City of Elysian.
- 14. The applicant for a License shall acquire and keep in full force and effect for the duration of the permit, liability insurance in the minimum amount of \$1,000,000 that specifically covers use of the property as a Short Term Rental.
- 15. All properties shall have a manager of the property who is capable of effectively handling complaints and issues arising at the property. The rental owner, operator, or manager shall designate a local contact on the license application that meets the following requirements:
 - a. Must be able to respond within ten (10) minutes via phone and within thirty (30) minutes in person.
 - b. Has administrative authority over the property and guests.
 - c. Has knowledge of the vacation rental unit, the property, rental and City rules, standards, and procedures, and effectively handles the same.
- 16. An operations Guide shall be available within the premises and provided to users of the property that includes the following information:
 - a. Manager Contact Information
 - b. Maximum Capacity
 - c. Parking Restrictions
 - d. Quiet Hours
 - e. Campfire Information
 - f. Watercraft Information
 - g. Rules of the Rental
 - h. Emergency contacts (police, fire, hospital, City Offices)
 - i. Boundary Lines
- (C) Licenses.

- 1. It shall be unlawful for any person, firm, corporation, partnership, or otherwise to operate a lodging establishment herein called for within the City who does not possess a valid Short Term Rental license.
- 2. Application. Any person desiring to operate a property or structure thereon which consists of non-traditional lodging for over-night stays on a daily or weekly basis of thirty (30) days or less of a private single-family dwelling, cabin, or condominium which provides basic living accommodations including sleeping space, toilet, and cooking space shall first be licensed by the City of Elysian. Any such person or entity shall apply for the License through the City Administrator or the City Administrator's Designee.
- 3. Inspections-Initial Inspection and Thereafter Every Three Years. The property shall initially be inspected by a licensed building inspector and pass such inspection. Inspections, and passage of the same, shall take place upon initial grant of the License with an additional inspection each three (3) years thereafter.
- 4. Licenses-Renewal. Each license shall be good for one year. Licenses shall be issued during the year and shall expire on December 31 of each and every year. Automatic renewals do not occur. License renewal applications shall be submitted to the City on forms provided by it, with the renewal fee, no later than one month proceeding the date of expiration.
- Renewal Fee Schedule. Initial and renewal license applications shall be accompanied by the applicable fee. All license fees are non-refundable. License fees shall be established in accordance with the City's Fees Schedule as it may be Amended from time to time.
- 6. Licenses are Non-Transferable including change of ownership situations.

(D) Inspection/Enforcement.

- 1. The City shall contract with a professional inspector to verify compliance with the terms and conditions of this Ordinance.
- The establishment to be regulated hereunder shall fully comply with the Minnesota State Building Code, State Fire Code, State Mechanical Code, City's Ordinances, City's Zoning Code, and the Terms and Provisions of this Ordinance.
- 3. The person operating an establishment shall, upon request of the City or City's Inspector, permit access to all parts of the establishment at any reasonable time for the purpose of inspecting and shall exhibit and provide such records necessary to ascertain compliance with the provisions of this Ordinance.

- 4. Any noted deficiencies noted by the inspector shall be remedied timely as determined by the Inspector.
- (E) Suspension and/or Revocation of License.
 - 1. Licenses may be suspended temporarily by the City Administrator, at any time for failure of the license holder to comply with the terms and requirements of this Ordinance. Notice of temporary suspension shall be mailed by first class U.S. Mail to the address indicated on the License Application. The Applicant shall be entitled to an opportunity for a hearing before the City Council to address the temporary suspension. Said request for hearing shall be filed with the City Administrator within ten (10) working days of the City Administrator's notice of revocation. In the event that the time parameter set forth herein is not complied with then the License Holder shall be deemed to have waived their right to a hearing on the suspension issue.
 - 2. Emergency Closure. Whenever the City finds that an emergency exists which requires immediate action to protect public health, it may, without notice or hearing, issue an Order reciting the existence of an emergency and require that such action be taken as deemed necessary to meet the emergency. Notwithstanding the other provisions of this Ordinance, such Order shall be effective immediately. Any person to whom an Emergency Order is directed shall comply therewith immediately.
 - a. Emergency Closure Procedure. Emergency Closure of an establishment will be ordered if a prohibited activity is occurring or it is determined that the Establishment is an imminent health hazard.
 - Following an Emergency Closure, the establishment shall not reopen or allow others to be permitted to be on the site, without written permission from the City.
 - c. The City must give written permission to reopen upon submission of satisfactory proof that the property condition(s) causing the need for emergency closure have been corrected or removed by the operator(s).
 - F. Penalty for Violation. Any violation of the Ordinance, by either the owner, tenant, occupant, manager, or such other person having control over or being present at the establishment is a Misdemeanor Offense punishable a fine of up to \$1,000 or ninety (90) days imprisonment. The first offense shall be a scheduled fine of \$500, the second offense shall be a scheduled fine of \$750 and the third offense shall be a scheduled fine of \$1,000.
 - G. Revocation of License. Upon an license holder's third conviction in two years for any violation of the terms and conditions of this Ordinance or the terms and conditions of any provision of the City's nuisance ordinances, the license shall be reviewed by the City Council for possible revocation and upon a fourth violation in two years it shall be automatically revoked by the City Council.

Upon either situation, the Applicant shall be entitled to an opportunity for a hearing before the City Council to address the revocation issue. Said request for hearing shall be filed with the City Administrator within ten (10) working days of the City Administrator's notice of revocation. In the event that the time parameter set forth herein is not complied with then the License Holder shall be deemed to have waived their right to a hearing on the suspension issue.

H. Effective Date. The Ordinance shall be in full force and effect as of January 1, 2020, or upon its publication, whichever occurs later.

Mayor McBroom presented draft Ordinance No. 91/19 – An Ordinance of the City of Elysian, Minnesota Relating to Tobacco, Electronic Delivery Devices, and Nicotine or Lobelia Delivery Products, and the like for discussion. He noted that the Ordinance had been discussed at the March 2019 City Council Meeting. At that time, the Council consensus was to wait and see what regulations the State of Minnesota put into place. McBroom stated he would like the Council to take action on this Ordinance. Minnesota has 23 cities and counties that require 21 years of age to purchase any type of tobacco products. There are many hazards of vaping devices and tobacco in general. North Mankato, Mankato, and Waseca have all passed ordinances requiring minimum age of 21. McBroom stated that for the sake of the youth, Elysian needs to get onboard with this regulation.

Moran explained that for the Ordinance to be considered, the next step would be to call a public hearing.

On motion by McBroom, seconded by Opsahl, to schedule a Public Hearing for consideration of Ordinance No. 91/19 (Ordinance will be renamed to No. 96/20 to reflect that it is being considered in 2020) – An Ordinance of the City of Elysian, Minnesota Relating to Tobacco, Electronic Delivery Devices, and Nicotine or Lobelia Delivery Products, and the like, for January 13, 2020 at 6:00 pm. Voting on the motion: Aye: McBroom, Opsahl. Nay: Schnoor. Motion passed.

Chris Cavett, SEH Engineering, presented Resolution No. 690/19 – Accepting Work for the 2018 Street and Utility Improvement Project. Cavett explained that most of the work was completed last season with the exception of final wear paving, saw and seal, and some warranty items. The City is currently holding 1% in retainage in the amount of \$16,940.42.

The original contract amount for the project was \$1,529,502.35. The final contract amount is \$1,628,107.69 or \$98,605 (6.4%) over the original contract amount. The increases are attributed to the added watermain crossing under Hwy 60, DNR trail crossing work, Tourism Building parking lot and additional sidewalk.

At this time, SEH is recommending that the project be accepted with the release of the final payment. The 2 year warranty would begin now and end on December 9, 2021. There are some current warranty items related mostly to concrete work that will be addressed Spring 2020 and have been acknowledged in writing by both the subcontractor and the contractor.

Schnoor stated he did not feel comfortable releasing the retainage and starting the warranty until the work was completed. There are a lot of issues out there yet. Cavett stated that it is not unreasonable to feel that way. There could be a lot of new issues out there in the Spring. Cavett is recommending accepting the project now because the subcontractor and contractor are both local. There is a comprehensive list of the needed repairs which includes concrete replacement and saw and seal.

Councilmember McBroom introduced the resolution and was seconded by Councilmember Opsahl.

A RESOLUTION DIRECTING UNPAID MOWING CHARGES

WHEREAS, Elysian City Code Ordinance 16 provides that all grass or weeds on private property or commercial property in the City limits of the City of Elysian shall be cut at regular intervals in order to maintain a continuity of order and benefit to property owners and to all property owners surrounding effective property; and

WHEREAS, property owners whose grass or weeds on private or commercial property that is longer than six (6) inches have been noticed and have a five (5) day window to have the grass or weeks cut or removed. If property owner ignores order, the City of Elysian has proceeded with the cutting or removal of grass or weeds and costs have been billed to the property owner; and

WHEREAS, the specified properties as set for in "Exhibit A" have ignored the order, the grass or weeds have been cut or removed, the property owner has been billed and received final notification that unpaid amounts will be assessed on the respective property tax rolls.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Elysian, Minnesota as follows:
