ELYSIAN CITY COUNCIL REGULAR MEETING OCTOBER 12, 2020

The Elysian City Council met in regular session on Monday, October 12, 2020 at City Hall at 6:00 pm.

Roll Call: Mayor Tom McBroom; Councilmembers Bobby Houlihan, Mary Opsahl, Dennis Schnoor, Bryan Suemnick; City Administrator Lorri Kopischke; Public Works Worker Don Doehling; City Attorney Jason Moran. Absent: None.

On motion by Houlihan, seconded by Opsahl, all voting in favor, to approve the minutes of the September 14, 2020 Regular Meeting as presented.

On motion by Houlihan, seconded by McBroom, all voting in favor, to approve the agenda of the October 12, 2020 Regular Meeting with the following additions:

- 1. Elysian Township Donation (Defibrillator)
- 2. City Property.

Le Sueur County Chief Deputy Nick Greenig acknowledged a concern with some behaviors occurring after closing time of the bars at night. Greenig reported the buoys are being removed from area lakes.

On motion by Opsahl, seconded by Houlihan, all voting in favor, to close the meeting and open the Public Hearing at 6:06 pm.

The purpose of the hearing is to allow public input from citizens on proposed Ordinance Amendment to City of Elysian Code of Ordinance Chapter 92: Parks and Recreation Section 92.01 City Park Regulations Item (C).

The Park Board has requested Ordinance Section 92.01 be amended to allow Lake Tustin Park to be a "dog-friendly" park. The Planning and Zoning Commission discussed Ordinance Section 92.01 at the September 1, 2020 Meeting and made the following recommendation:

REMOVE "(C) No animals are permitted in any part of all parks. Leashed animals are allowed in the parking lot area and may be allowed to swim/exercise in the area at the north end of the parking area. Pet owners are responsible for the behavior of their pets and for cleaning up and removing items associated with their pet."

And

INSERT "(C) Leashed animals are allowed in designated areas of all City parks. Pet owners are responsible for the behavior of their pets and for cleaning up and removing items associated with their pets. There will be no animals allowed in the beach area of the City parks in the peak season – Memorial Day through Labor Day."

The Park Board / City Council shall determine in what parks and in which area of those parks that animals are allowed. Signs would be erected to show which areas allow animals and which areas do not.

Schnoor stated that the suggested verbiage sounds like dogs are allowed at all the parks. The Park Board discussed the proposed change and did not approve. The Park Board wants dogs to be allowed at the Lake Tustin Park only.

The Council discussed the proposed amendment and there was consensus to only allow dogs at the Lake Tustin Park. No dogs to be allowed at the Lake Francis Park or Sunset Park.

There were no public comments. No written comments were received.

On motion by Schnoor, seconded by Houlihan, all voting in favor, to close the public hearing and open the regular meeting at 6:16 pm.

Public Comment: None.

The Council considered Ordinance Amendment to City of Elysian Code of Ordinance Chapter 92: Parks and Recreation Section 92.01 City Park Regulations Item (C).

On motion by Houlihan, seconded by Schnoor, all voting in favor, to direct the City Attorney to rewrite the amendment to City of Elysian Code of Ordinance Chapter 92: Parks and Recreation Section 92.01 City Park Regulations Item (C) to reflect that dogs are only allowed at the Lake Tustin Park. The amendment will be considered at the November 9, 2020 Council Meeting.

The Council then considered Resolution #718/20 – Variance Application of Michael and Rita Considine, 403 First Street N, to remove and replace a portion of the cabin / home and build a garage. The requested variance specifically seeks the following: Required setback from rear lot line for the principal structure 20 feet – requested 11 feet and required lot area 20,000 square feet – requested 16,700 square feet.

The parcel is split by the driveway to the neighbor's property to the west. The cabin is located on the south side of the driveway and a small guest house is located on the lakeside portion of the parcel. The proposed garage would be built on the east side of the existing cabin. It would be 18 x 24 feet and would be attached to the cabin with the entrance door facing north toward the lake. The addition to the cabin would be on the west side and would involve removing a portion of the existing building and rebuilding and expanding toward the north toward the lake to match up with the remaining existing portion of the cabin / house.

The current cabin structure is 11 feet from the rear lot line. The addition would not increase this non-conformity. The addition would start in this location and be built toward the lake. All other setback requirements are met.

The Planning and Zoning Commission considered the application at their October 6, 2020 meeting and is recommending approval based on the following findings of fact:

- The property owner does propose to use the property in a reasonable manner because it is rebuilding what is there and bringing the cabin up to code so it can be used as a retirement home. It does not expand toward the lake or encroach into the OHW setback. The garage and rebuild will stay within the current rear yard setback and will not increase the nonconformity.
- 2. There are unique circumstances to the property not created by the landowner because the neighboring property's driveway runs through the center of the lot.
- The variance will maintain the essential character of the locality because it will provide an overall improvement to the property. Staying on this side of the driveway and 100 feet back from the OHW will keep with the essential character of the neighborhood.

Mayor McBroom introduced the resolution and was seconded by Councilmember Opsahl.

RESOLUTION ADOPTING FINDINGS OF FACT AND REASONS FOR APPROVAL FOR VARIANCE APPLICATION OF MICHAEL CONSIDINE AT 403 NORTH FIRST STREET

FACTS

- 1. Michael and Rita Considine are the owners of a parcel of land located at 403 First Street North, Elysian, Minnesota; and,
- 2. The subject property is legally described as found on Exhibit A; and,
- 3. Michael and Rita Considine have applied to the City for a variance to build an attached garage and a rebuild / addition to their cabin / home as described on Exhibit B1 and B2.
- 4. The proposal would vary from §156.065 R-1, General Residential Zone, (E) R-1 Standards (4) Rear yard, principal building: minimum of 20 feet and §156.091 General Standards (B) (1) (a) Single-Family lot area 20,000 square feet, in that it would result in a rear yard setback of 11 feet and the lot area is 16,700 square feet.
- 5. Following a public hearing on the application, the Elysian Planning and Zoning Commission has recommended approval of the variance on October 6, 2020.
- 6. The City Council of the City of Elysian reviewed the requested variance at its Meeting of October 12, 2020.

APPLICABLE LAW

- 7. Minnesota Statute Section 462.357, subd. 6 provides:
 - a. Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
 - b. Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

CONCLUSIONS OF LAW

- 8. The property owner does propose to use the property in a reasonable manner because it is rebuilding what is there and bringing the cabin up to code so it can be used as a retirement home. It does not expand toward the lake or encroach into the OHW setback. The garage and rebuild will stay within the current rear yard setback and will not increase the nonconformity.
- 9. There are unique circumstances to the property not created by the landowner because the neighboring property's driveway runs through the center of the lot.

- 10. The variance will maintain the essential character of the locality because it will provide an overall improvement to the property. Staying on this side of the driveway and 100 feet back from the OHW will keep with the essential character of the neighborhood.
- 11. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elysian, Minnesota, that the application to issue a variance to allow Michael and Rita Considine to build an attached garage and a rebuild / addition to his cabin / home so as to deviate from §156..065 R-1, General Residential Zone, (E) R-1 Standards (4) Rear yard, principal building: minimum of 20 feet and §156.091 General Standards (B) (1) (a) Single-Family lot area 20,000 square feet, in that it would result in a rear yard setback of 11 feet and the lot area is 16,700 square feet is hereby Approved.

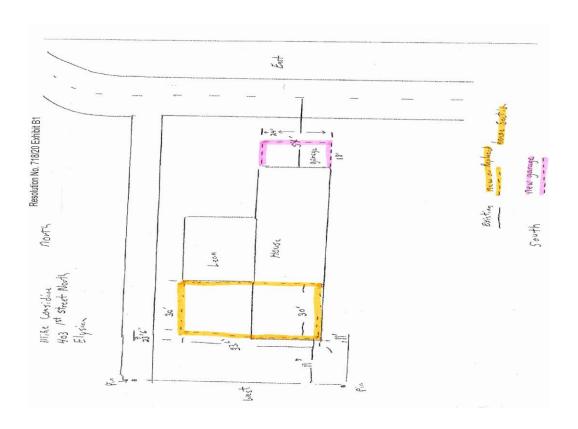

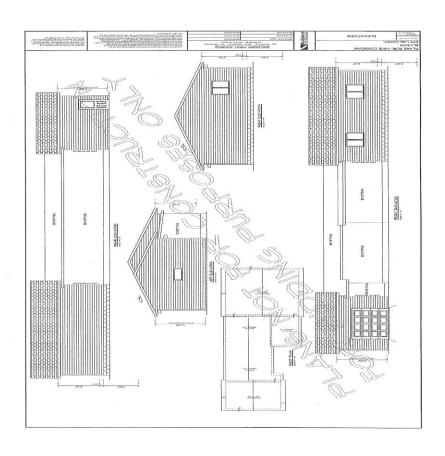

Resolution Allocating Coronavirus Aid, Relief and Economic Security Act Funds (Known as the CARES Act Funds) to Local Government Activities

WHEREAS, on March 27, 2020 the President of the United States signed into law the Coronavirus Aid, Relief and Economic Security Act (Known as the CARES Act) that was passed by the U.S. Congress in response to the COVID-19 Pandemic Outbreak; and,

WHEREAS, The CARES Act included \$339.8 Billion in relief under the COVID-19 pandemic in the United States dedicated for State and Local Governments; and,

WHEREAS, on June 25, 2020 the Governor of the State of Minnesota by Executive Order under the current Emergency allowed for the distribution of \$841 million in CARES Act Funds to counties and cities within the State of Minnesota in accordance with the U.S. Treasury Guidance based on a per-capita basis; and,

WHEREAS, the City of Elysian has received \$53,642.00 in CARES Act Funding allocation; and,

WHEREAS, the CARES Act allows local governmental units to expend funds on costs that are necessary expenditures related to the COVID-19 public health emergency; and,

WHEREAS, the CARES Act allows local governmental units to expend funds on costs that were not included in the most recently adopted budget as of March 27, 2020, or were budgeted for but have been incurred for a substantially different use from what was intended as a result of the COVID-19 public health emergency; and,

WHEREAS, the CARES Act allows local governmental units to expend funds on costs that were incurred during the covered period of March 1, 2020 – November 15, 2020.

City Administrator

Don Doehling, Public Works Worker, presented a proposal from Bargen, Inc. to seal coat the following areas:

Shop lot: \$2,100
Lake Drive and Path: \$3,300
Park parking lot: \$600
Street behind City Hall: \$1,550
Tourism Center parking lot: \$500
Total: \$8,050

Mayor

Bargen uses a RePlay Procedure which applies a clear sealcoat. They will clean the area in preparation for the Sealcoat. The RePlay Agricultural Oil Seal and Preservation Agent will be spray applied in one coat. RePlay is designed to extend the life of new and existing asphalt surface. Price includes all materials, applicable taxes, and labor to complete the project as explained.

Doehling explained that Council can choose which areas to RePlay. The most important would be the Lake Drive and Path.

There are no monies budgeted for this. It was suggested monies from the Cable Savings Account could be utilized.

On motion by Schnoor, seconded by McBroom, all voting in favor, to approve the proposal from Bargen, Inc. in the total amount of \$8,050 to RePlay the shop lot, lake drive and path, park parking lot, street behind City Hall, and Tourism Center parking lot with the funds coming from the Cable Savings Account.

The Council considered Resolution No. 720/20 Approving the Financing for fourteen (14) Scott X3 Pro SCBAs, Twenty-Eight (28) Cylinders, and related equipment. The Fire Department's SCBAs expire at the end of 2020. Grant funds have been pursued over the past three years but have not been received. The leasing agreement has been presented to and approved by the Elysian, losco and Janesville Township Boards. The total cost of the equipment is \$93,602.60. A down payment of \$40,000 will be made from the Joint Fire Saving Account. The remaining amount of \$53,602.60 will be financed over the next three (3) years with a yearly payment of \$19,086.57 to be split as follows: City of Elysian (50%), Elysian Township (37.02%), losco Township (6.49%), and Janesville Township (6.49%).

The Council discussed an uncollectible garbage service debt for 108 First Street S. Lot #2. On motion by McBroom, seconded by Houlihan, all voting in favor, to write off the outstanding amount of uncollectible debt for garbage services in the amount of \$1,125.86 for 108 First Street S. Lot #2.

Public Works employees have requested a budget amount for winter boots. The boots would be insulated and be steel or composite toe as required by OSHA. They currently are allowed one pair of boots every two years.

Schnoor discussed the removal of the berm in the alley behind his lot. The berm was installed in the 1990s and was meant to keep the corn stalks and trash from washing into that area and plugging the catch basins in that alley. During the 7+ inch rain event this summer, the neighbors dug out the berm and leveled the area.

The Council discussed the large amount of storm water flowing into that area of the City and the need to update the storm sewer system with the next street and utility project.

There was Council consensus to direct Public Works staff to rebuild the berm so it can continue to serve the purpose of keeping debris out of the catch basins in that location and that the storm sewer system in that area will be addressed with the next street and utility project in that area.

Mayor McBroom reported the City Administrator evaluation was conducted earlier this evening. Overall Kopischke met or exceeded the expectations of her job requirements.
