## ELYSIAN CITY COUNCIL REGULAR MEETING SUMMARY MARCH 11, 2024 AT 6:00 PM

Present: Mayor Tom McBroom, Sr.; Councilmembers Bobby Houlihan, Dennis Schnoor; Bryan Suemnick, and Derek Westby; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald; City Attorney Jason Moran. Absent: None

The meeting opened with the Pledge of Allegiance to the US Flag.

Approved the minutes of the February 12, 2024 Regular Meeting.

Le Sueur County Commissioner Rohlfing reported that phase 2 of the government center remodel should be completed this month with the parking lot renovation completed at the end of July. Commissioners are working on a

policy to address safety concerns at intersections. In response to the discussion at the January Council meeting regarding the curve on County Road #11 by Glen's Beach, the county is requesting to clear cut some trees off the land to make a clear path so that if a vehicle does go off the road, it will not hit an object and result in injury or death. Suemnick asked if the radius of the curve of the actual road could be changed.

Rohlfing reported bids are being opened for sealcoat and road striping. CSAH 16 from CSAH 13 to CSAH 15 will be rehabbed this summer. The feed lot ordinance has been completed and Commissioners are working on updating the solid waste ordinance. The Comprehensive Plan is being updated.

Le Sueur County Chief Deputy Nick Greenig reported all has been quiet in the City. The Council asked Greenig to address a small black car that has been traveling at very high speeds on State Highway 60, stop sign violations at the corner of Main Street and County Road #11, and vehicles parked in the no parking zone on Third Street SW.

Held a public hearing and adopted Ordinance #112/24 – An Ordinance Repealing Chapter 154 – Floodplain Management in its Entirety and Replacing Enacting Ordinance #112/24 Floodplain Management.

Set a public hearing for consideration of Ordinance #113/24 – An Ordinance Regulating Native Plantings consistent with MSA §412.925 for April 8, 2024 at 6:15 pm.

Accepted a proposal from Braun Intertec in the Lump Sum of \$23,210 to perform soil testing and make recommendations for the WTP foundation, as well as recommendations for the water main installation.

Accepted a proposal from Wigen Water in the amount of \$115,750 to perform a 3-month Reverse Osmosis Pilot Study for the WTP to include greensand gravity filter pretreatment.

Approved Resolution #889/24 – Supporting Application to Minnesota Department of Natural Resources for Regional Trail Program.

Directed staff to provide quotes for a 72" deck Toro, John Deere, and Cub Cadet mower with tweels.

Directed staff to obtain a quote to tint the City Hall windows.

Reviewed the Commercial Environmental Utility fees and capped the rate at \$175 per month.

Set a public hearing to consider a request for off sale, on sale, and Sunday Liquor for KRO Bar, Inc. d/b/a Thirsty Beaver Bar for April 8, 2024 at 6:05 pm.

Accepted the Resignation of Firefighter Bobby Houlihan effective January 31, 2024.

Accepted the Resignation of Firefighter Matthew Olson effective January 15, 2024.

Approved Resolution #890/24 – Accepting a Donation from Ron and Laura Romnes for the Sunset Park Sports Court Renovation.

Approved Resolution #891/24 – Approving State of Minnesota Joint Powers Agreements with the City of Elysian on behalf of its City Attorney.

Approved renewal of the 10-year Elysian Area Fire Protection Agreement.

Set a special meeting for the Audit Report for April 8, 2024 at 5:30 pm.

Approved the 2024 Contract with Mosquito Control in the amount of \$4,060.

The EDA will fund the repair of the Wayside Rest sign and keep the postings up to date.

Reminder of Joint Meeting with City Council, Planning and Zoning Commission, and Economic Development Authority on February 27, 2024 at 6:00 pm to discuss the update to the Comprehensive Land Use Plan.

Received an update from Le Sueur County that a FEMA grant was received to complete the Upper Cannon River Flood Study. Received notice from Xcel Energy that smart meters will be installed on homes in Elysian April through September, 2024.
