ELYSIAN CITY COUNCIL REGULAR MEETING SUMMARY DECEMBER 8, 2025 AT 6:00 PM

Present: Mayor Dennis Schnoor; Councilmembers Steve Hoppe, Bobby Houlihan, and Paul Hunter; City Administrator Lorri Kopischke; Public Works Director Ron Greenwald; Absent: Councilmember Derek Westby and City Attorney Jason Moran.

Le Sueur County Deputy Alyson Powers reported that all is well in the City of Elysian. There is nothing to note.

Approved the Consent Agenda to include Minutes of November 10, 2025 Regular Meeting; Bills, Payroll, and Transfers in the amount of \$319,132.95; 2026 On Sale, Off Sale, Club, Sunday, and Soft Drink Licenses.

Public Works Director Greenwald reported that the water leak at 153 Shoreview Drive is repaired. There was a watermain break at 100 Frank Avenue NE that has been repaired. Lift Station B needed two floats replaced. That repair has been completed.

Held the Truth in Taxation Public Hearing and approved Resolution #980/25 – Adopting the 2026 Final Budget for the City of Elysian and Resolution #981/25 – Adopting Final 2025 Tax Levy, Payable 2026. The total final levy amount is \$967,712 which is an increase of \$42,964 or a 4.6% increase from last year. The largest increase is in the general fund resulting from a reduction in LGA Funding, increase salary and benefit costs, increased IT and infrastructure security costs, administration of 2026 elections, tree management Emerald Ash Borer Disease, and increase to Fire Department Budget. The increase to the total budget which includes all City funds (general, debt service, enterprise) is 2.7%. The City of Elysian Local Tax Rate decreased from 55.96 in 2025 to 54.89 in 2026. If you have any questions on the budget or the levy, please contact City Hall.

Approved the Agreement for Law Enforcement Services January 1, 2026 through December 31, 2029 – County of Le Sueur and City of Elysian.

Approved Resolution #976/25 – To Ratify Increase and Amend the Elysian Fire Department Relief Association Benefit Level and Bylaws to Increase the Annual Retirement Benefit from \$1,700 to \$1,800.

Approved Resolution #977/25 – Directing Delinquent Utility Charges to be Placed on the Property Taxes Payable in 2026.

Approved Resolution #978/25 – Directing Unpaid Mowing Charges to be Placed on the Property Taxes Payable in 2026.

Approved Resolution #979/25 – Directing Delinquent Second Water Meter Adaptation Parts Charges to be Placed on the Property Taxes Payable in 2026.

Approved a 3% COLA Wage Increase for the City of Elysian Full-Time Employees Effective the First Payroll in January 2026.

Scheduled End of the Year Meeting for Monday, December 29, 2025 at 6:00 pm.

Received report of meeting with House Representative Stier and Senator Draheim with continued discussion of the Bonding Funds Request for a Water Treatment Plant.

Approved the Agreement for Professional Services between the City of Elysian and Short Elliott Hendrickson, Inc. in the amount of \$7,000 for the Project described as: Verizon MN10 Elysian Repeater. The services are being paid by Verizon. There is no cost to the City of Elysian.

Five sealed bids were received for the 1991 4-wheel drive Ford F350 Custom Rescue Truck. The bid was awarded to the highest bidder, James Bros. Construction, with a bid amount of \$7,850.

Public Comment: Mayor Dennis Schnoor reported that the Elysian Fire Department Budget is funded by the City of Elysian and Elysian, losco, and Janesville Townships. The Fire Fighters currently receive \$12 per hour for training and fire calls. The \$10,000 increase to the Fire Department budget was to fund and increase the rate for training and fire calls to \$14 per hour.
